### A BILL FOR AN ACT

RELATING TO FOSTER CARE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Foster providers, including provisionally-
- 2 licensed and licensed resource family homes, group homes, and
- 3 child-caring institutions, are responsible for the care and
- 4 maintenance of children who are placed in their care. These
- 5 providers incur significant cost in fulfilling this
- 6 responsibility, which includes the cost of providing food,
- 7 shelter, clothing, transportation, daily supervision, medical
- 8 care, personal essentials, school supplies, and a wide array of
- 9 other necessities and services.
- 10 The legislature finds that the department of human services
- 11 renders foster care maintenance payments to foster providers to
- 12 cover costs incurred. However, even though funding was
- 13 allocated last year to increase foster care maintenance payments
- 14 for the first time in over two decades, the increased amount
- 15 would still be inadequate and still falls significantly below
- 16 the cost of adequate care and maintenance, considering the rate

- 1 of inflation. Based on inflation, the relative board rate would
- 2 be \$970 in today's economy.
- 3 The purpose of this Act is to increase the minimum monthly
- 4 foster care maintenance basic board rate and the maximum monthly
- 5 difficulty of care rate.
- 6 SECTION 2. Effective July 1, 2015, the department of human
- 7 services shall increase the monthly foster care maintenance
- 8 basic board rate to no less than \$ for payments made by
- 9 the department of human services directly to resource family
- 10 homes, group homes, and child-caring institutions under sections
- 11 17-1617-3 and 17-1617-4, Hawaii Administrative Rules.
- 12 SECTION 3. Effective July 1, 2015, the department of human
- 13 services shall increase the maximum monthly difficulty of care
- 14 rate to no less than \$ for payments made by the
- 15 department of human services directly to resource family homes,
- 16 group homes, and child-caring institutions under sections 17-
- 17 1617-3 and 17-1617-4, Hawaii Administrative Rules.
- 18 SECTION 4. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so much
- 20 thereof as may be necessary for fiscal year 2015-2016 and the

- 1 same sum or so much thereof as may be necessary for fiscal year
- 2 2016-2017 for the purposes of this Act.
- 3 The sums appropriated shall be expended by the department
- 4 of human services for the purposes of this Act.
- 5 SECTION 5. The department of human services shall submit a
- 6 report to the legislature on:
- 7 The status and costs of implementing this Act; (1)
- 8 (2) Any anticipated future costs related to implementing
- 9 this Act; and
- **10** The number of foster children affected by this Act; (3)
- 11 provided that for the purposes of this report a child
- 12 shall be counted from the first day the child enters
- 13 the foster care system,
- 14 no later than twenty days prior to the convening of the regular.
- 15 session of 2016.

**16** SECTION 6. This Act shall take effect on July 1, 2015.
