BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

5	disclosure. (a) When a contract holder makes the first claim on

7 .	the service contract shall disclose to the contract holder that,
8	pursuant to section 481X-7(b), if the claim is charged against
9	the service contract, the contract holder shall not be entitled
10	to a refund of the full purchase price of the service contract.
11	(b) Upon presentation of the first claim, a contract

- 3 SECTION 3. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were

- 6 SECTION 4. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect on June 30, 2112.
