

### A BILL FOR AN ACT

RELATING TO LEGISLATIVE JURISDICTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to cede concurrent
- 2 legislative jurisdiction to the United States as to specific
- 3 property that was acquired by or for the United States
- 4 Department of the Navy after the Hawaii Statehood Act of 1959,
- 5 Public Law 86-3. Concurrent legislative jurisdiction already
- 6 exists as to properties controlled or owned by the United States
- 7 for Defense or Coast Guard purposes as of the Hawaii Statehood
- 8 Act. This Act would achieve uniformity in the jurisdiction over
- 9 the Navy's land in Hawaii and would allow for reciprocal law
- 10 enforcement authority.
- 11 SECTION 2. Section 1-4.5, Hawaii Revised Statutes, is
- 12 amended to read as follows:
- "[+] §1-4.5[+] Cession of concurrent jurisdiction. (a)
- 14 Notwithstanding the provisions of any other law, the State of
- 15 Hawaii hereby cedes concurrent legislative jurisdiction to the
- 16 United States over the following:

3	(b) Cession of concurrent legislative jurisdiction, in		
4	accordance with subsection (a), shall only take effect upon the		
5	acceptance of such jurisdiction by the United States. The		
6	concurrent legislative jurisdiction so ceded shall end as to any		
7	such lands, improvements, or such portions thereof, that cease		
8	to be owned, leased, occupied, or controlled by or on behalf of		
9	the United States for correctional purposes.		
10	(c) The State of Hawaii retains concurrent legislative		
11	jurisdiction, both civil and criminal, with the United States		
12	over all lands specified in subsection (a)."		
13	SECTION 3. This Act does not affect rights and duties that		
14	matured, penalties that were incurred, and proceedings that were		
15	begun before its effective date.		
16	SECTION 4. Statutory material to be repealed is bracketed		
17	and stricken. New statutory material is underscored.		
18	SECTION 5. This Act shall take effect upon its approval.
