- 9 SECTION 7. This Act shall take effect on July 1, 2016.

Urn; Theft; Penal Code; Class C Felony; Scrap Dealers; Statement; Desecration

Description:

Establishes the offense of theft of urn as a class C felony. Requires scrap dealers to follow the same requirements regarding a written statement for the purchase of an urn as they do for the purchase of copper or a beer keg. Includes the intentional desecration of a columbarium or an urn under the offense of desecration. (SD1)
