A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR AFTER-SCHOOL PROGRAMS FOR PUBLIC MIDDLE AND INTERMEDIATE SCHOOL STUDENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Established in 1990 by the department of
- 2 education, the State's after-school plus (A+) program provides
- 3 after-school care, including enrichment activities and
- 4 supervised recreational activities, until 5:30 p.m. on each
- 5 school day at more than one hundred ninety participating
- 6 schools. The program is supported by \$6,000,000 in general
- 7 funds, and the current agreement provides for a payment of \$85
- 8 per month for each eligible child. Elementary-school-aged
- 9 children whose parents work, attend school, or are in job-
- 10 training programs are eligible to participate.
- 11 However, none of this funding is available to the
- 12 department of education's middle and intermediate schools to run
- 13 structured after-school programs. According to the Afterschool
- 14 Alliance, each afternoon across the United States, fifteen
- 15 million children are alone and unsupervised after school.
- 16 Countless parents have indicated that they would enroll their

- 1 children in an after-school program, if one were available. Of
- 2 Hawaii's fifty-five middle and intermediate schools, forty-two
- 3 are designated as Title I, meaning that forty per cent or more
- 4 of the student population qualify for free or reduced-price
- 5 lunches.
- 6 The legislature finds that high-quality after-school
- 7 programs targeted toward Hawaii's public middle and intermediate
- 8 school students would generate significant returns on investment
- 9 for society as a whole. It costs \$12,000 per student for a six-
- 10 hour day in school and approximately \$1,000 for three hours in
- 11 an after-school program. Positive returns would also be
- 12 realized with respect to the prevention of teen pregnancies,
- 13 drug abuse, and juvenile crime and delinquency. High-quality
- 14 after-school programs would help prevent Hawaii's youth from
- 15 heading down the wrong path.
- 16 The after-school hours are a critical period of time. The
- 17 hours between 3:00 p.m. and 6:00 p.m. are the peak hours for
- 18 juvenile crime and delinquency as well as experimentation with
- 19 alcohol, tobacco, illegal drugs, and sex. Without adult
- 20 supervision, this is the period of time when youth violence,

- 1 drug use, and other delinquent behaviors are most likely to
- 2 occur.
- 3 Students in middle and intermediate school constitute an
- 4 age group historically underserved by after-school program
- 5 providers. In Hawaii, there are many programs for elementary
- 6 school students in the form of structured day care, such as the
- 7 A+ program. On the other hand, high schools offer numerous
- 8 clubs, teams, and extra-curricular activities for students.
- 9 However, middle and intermediate school students are often left
- 10 with few safe and structured opportunities between 3:00 p.m. and
- 11 6:00 p.m.
- 12 At a time when middle- and low-income families and
- 13 communities are struggling financially and children are falling
- 14 behind academically, after-school programs are needed more than
- 15 ever. A powerful convergence of factors--including a lack of
- 16 federal, state and local funding, and families and communities
- 17 working with tight budgets--leaves 68,665 of Hawaii's school-
- 18 aged children alone and unsupervised after the school day ends.
- 19 After-school programs not only keep students safe but they also
- 20 provide students with productive, enjoyable, and innovative
- 21 enrichment and health and fitness activities.

- 1 The purpose of this Act is to appropriate funds to provide
- 2 after-school programs in Hawaii's public middle and intermediate
- 3 schools, with high-quality, structured after-school supervision
- 4 for students enrolled in grade six to grade eight.
- 5 SECTION 2. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so much
- 7 thereof as may be necessary for fiscal year 2016-2017 for the
- 8 establishment of after-school programs for public middle and
- 9 intermediate school students.
- 10 The sum appropriated shall be expended by the department of
- 11 education for the purposes of this Act.
- 12 SECTION 3. This Act shall take effect on July 1, 2050.
