A BILL FOR AN ACT

RELATING TO MOPEDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-2, Hawaii Revised Statutes, is
- 2 amended by amending the definitions of "motor vehicle" and
- 3 "vehicle" to read as follows:
- 4 ""Motor vehicle" means every vehicle [which] that is self-
- 5 propelled and every vehicle [which] that is propelled by
- 6 electric power but [which] that is not operated upon rails[, but
- 7 excludes a moped].
- 8 "Vehicle" means every device in, upon, or by which any
- 9 person or property is or may be transported or drawn upon a
- 10 highway, but excludes devices moved by human power or devices
- 11 used exclusively upon stationary rails or tracks [and mopeds]."
- 12 SECTION 2. Section 286-26, Hawaii Revised Statutes, is
- 13 amended by amending subsection (b) to read as follows:
- 14 "(b) All other vehicles, including mopeds, motorcycles,
- 15 trailers, semitrailers, and pole trailers having a gross vehicle
- 16 weight rating of 10,000 pounds or less, and antique motor
- 17 vehicles as defined in section 249-1, except those in

- 1 subsections (c) and (d), shall be certified as provided in
- 2 subsection (e) every twelve months; provided that any vehicle to
- 3 which this subsection applies shall not require inspection
- 4 within two years of the date on which the vehicle was first
- 5 sold."
- 6 SECTION 3. Section 291C-202, Hawaii Revised Statutes, is
- 7 amended by amending subsection (c) to read as follows:
- 8 "(c) [The director of transportation by rules and
- 9 regulations, pursuant to chapter 91, shall establish criteria
- 10 and procedures for the annual safety-inspection of every-moped.]
- 11 Every moped shall be inspected in accordance with section 286-
- 12 26. Safety inspection criteria shall include the criteria
- 13 established by the director of transportation under subsection
- 14 (b)."
- 15 SECTION 4. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 5. This Act shall take effect upon its approval.
