#### A BILL FOR AN ACT

RELATING TO VOTER REGISTRATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
  by adding a new section to part II to be appropriately
- 3 designated and to read as follows:
- 4 "S11-A Applications for a civil identification card or
- 5 driver's license. (a) Notwithstanding any law to the contrary,
- 6 an affidavit on application for voter registration shall be a
- 7 part of the application associated with the issuance of a civil
- 8 identification card under section 286-301 and a driver's license
- 9 under section 286-109.
- 10 (b) Applications for a civil identification card or
- 11 driver's license shall not be processed until the applicant has:
- 12 <u>(1)</u> Applied to register to vote; or
- 13 (2) Affirmatively declined to register to vote.
- (c) If an applicant for a civil identification card or
- driver's license is already a registered voter, the application
- shall serve to automatically update the applicant's voter
- 17 registration residence address, mailing address, or name, as may

1 be applicable. A notice to this effect shall be stated on any 2 application or change of address or name form utilized by the 3 examiner of drivers. 4 The examiner of drivers shall electronically transmit 5 to the office of elections, on a real time basis, the following 6 information, as may be available, associated with each person 7 who submits an application for a driver's license or civil 8 identification card, or who submits a notice of a change of name 9 or address: 10 (1) Name; 11 (2) Date of birth; 12 (3) Residence address; 13 (4) Mailing address; 14 (5) Digitized signature; 15 (6) Telephone number; 16 (7) Email address; 17 (8) Gender; 18 (9) Any address associated with a previous registration in 19 another state the person authorizes to be canceled;

4	(11)	Whether the person chooses to become a permanent							
5		absentee voter;							
6	(12)	Whether the applicant was informed, if they are

10		reflect what has been provided in their application;							
11	(13)	An electronic copy of the application in portable							
12		document format;							
13	(14)	Whether the person applied to register to vote or							
14		declined to register to vote; and							
15	(15)	Other information specified by the chief election							
16		officer.							
17	<u>(e)</u>	Databases maintained or operated by the counties or							
18	the depar	tment of transportation containing driver's license and							
19	civil identification card information, including any documents								
20	or images, shall be electronically accessible by election								
21	officials and the statewide voter registration system, to allow								

- 1 for the timely processing of voter registration applications,
- 2 facilitate verification of information provided by online voter
- 3 registration applicants under section 11-15.3, ensure the
- 4 integrity of the voter registration rolls, or for any other
- 5 election purpose."
- 6 SECTION 2. Section 286-109, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "§286-109 General provision governing the issuance of
- 9 licenses. (a) Upon payment of the required fee and upon
- 10 demonstrating the ability to operate a certain category or
- 11 categories of motor vehicles to the satisfaction of the examiner
- 12 of drivers, an applicant for a driver's license shall be issued
- 13 a single license of a design approved by the director of
- 14 transportation upon which is made a notation of:
- 15 (1) The category or categories of motor vehicles the
- applicant may operate;
- 17 (2) Any restrictive provisions to which the license is
- 18 subject;
- 19 (3) Veteran status, if desired by the applicant; provided
- 20 that the notation shall be on the front of the license

- When the license is issued to a person under twentyone years of age, a statement, in clearly legible

  print that shall contrast with the other information
  appearing on the license, which indicates the date on
  which the person will attain the age of twenty-one
  years.
- 9 As used in this subsection, "veteran" means any person who
  10 served in any of the uniformed services of the United States and
  11 was discharged under conditions other than dishonorable.
- (b) The examiner of drivers shall not issue or renew any driver's license using the driver's social security number on the driver's license.
- (c) Statutes of limitations and other provisions of this chapter notwithstanding, no driver's license or instruction permit shall be issued or renewed under this section, where the examiner of drivers is notified by the district judge, traffic violations bureaus of the district courts, or the judge of the circuit court that the applicant has failed to respond to a traffic citation or summons, or failed to appear in court after

- 1 an arrest for the violation of any traffic laws of a county,
- 2 this chapter or chapter 286G, 287, 290, 291, or 291C, or of any
- 3 motor vehicle insurance laws under article 10C of chapter 431,
- 4 or of any motorcycle or motor scooter insurance laws under
- 5 article 10G of chapter 431, and the same remains delinquent and
- 6 outstanding, or the applicant, has as of the time of the
- 7 application, failed to comply in full with all orders of the
- 8 court; provided that the district court with whose order an
- 9 applicant has failed to comply in full, may approve the issuance
- 10 or renewal of a driver's license or instruction permit other
- 11 than a commercial driver's license upon conditions imposed by
- 12 the court for the satisfaction of the outstanding court order
- 13 and any other conditions as may be imposed by the court, if one
- 14 or more of the following conditions are met:
- 15 (1) The applicant is gainfully employed in a position that
- requires driving and will be discharged if the
- applicant is unable to drive; or

- 5 A driver's license or instruction permit issued or renewed
- 6 under this subsection shall be subject to immediate suspension
- 7 by the court upon the applicant's failure to remain in full
- 8 compliance with all conditions imposed by the court for the
- 9 issuance or renewal of the driver's license or instruction
- 10 permit. The examiner of drivers may place an indication of

- 12 or renewed under this subsection. Proof of financial

- 19 SECTION 3. Section 286-301, Hawaii Revised Statutes, is
- 20 amended to read as follows:

- 1 "[+] §286-301[+] Issuance of identification card or
- 2 temporary card. (a) To obtain an identification card from the
- 3 examiner of drivers, an individual shall complete an application
- 4 pursuant to section 286-303.
- 5 (b) The examiner of drivers, upon receipt of the
- 6 application by any individual who is a resident or a temporary
- 7 resident of this State, shall issue an identification card to
- 8 that individual upon receipt of any appropriate fee established
- 9 pursuant to section 286-309.
- 10 (c) The identification card shall be similar in size,
- 11 shape, and design to a driver's license, but shall not entitle
- 12 the individual to whom it is issued to operate a motor vehicle.
- 13 (d) The issuance of an identification card pursuant to
- 14 this section shall not place upon the State of Hawaii or any
- 15 agency any liability for the misuse or the acceptance of the
- 16 identification card as valid identification, which shall be left
- 17 entirely to the discretion of any individual to whom such card
- 18 is presented.
- 19 (e) An application for an identification card from the
- 20 examiner of drivers shall include the information required under
- 21 section 11-A."



- 1 SECTION 4. Section 286-311, Hawaii Revised Statutes, is
- 2 amended by amending subsection (a) to read as follows:
- "(a) [All] Except as required by sections 11-A, 286-109,
- 4 and 286-301, information and records acquired by the examiner of
- 5 drivers under this part shall be confidential. All information
- 6 and records shall be maintained in an appropriate form and in an
- 7 appropriate office in the custody and under the control of the
- 8 examiner. The information shall be available only to authorized
- 9 individuals under such restrictions as the director shall
- 10 prescribe. The examiner may dispose of any application or
- 11 identification card, or information or record relating to the
- 12 application or identification card, which does not include a
- 13 social security number, without regard to chapter 94, whenever,
- 14 in the examiner's discretion, retention of the information or
- 15 record is no longer required or practicable."
- 16 SECTION 5. In codifying the new sections added by section
- 17 1 of this Act, the revisor of statutes shall substitute
- 18 appropriate section number for the letter used in designating
- 19 the new sections in this Act.
- 20 SECTION 6. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.
