A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many motor vehicle
- 2 insurance companies offer insurance documents through
- 3 applications on mobile electronic devices. This electronic
- 4 proof of coverage gives drivers a convenient, paperless way to
- 5 display up-to-date insurance information.
- 6 The legislature further finds that more states are
- 7 recognizing the widespread use of mobile technology and updating
- 8 motor vehicle insurance laws accordingly. Currently, thirty-
- 9 seven states permit drivers to use an electronic copy of their
- 10 insurance card as valid proof of insurance. The acceptance of
- 11 this technology has grown rapidly since March 2012, when Idaho
- 12 became the first state in the country to accept electronic motor
- 13 vehicle insurance cards.
- 14 The legislature concludes that owners and drivers of motor
- 15 vehicles in Hawaii should also be provided with electronic
- 16 options for proof of insurance.
- 17 Accordingly, the purpose of this Act is to allow electronic
- 18 insurance cards, in addition to paper insurance cards, to be

- 1 used as proof of insurance for motor vehicles, motorcycles, and
- 2 motor scooters.
- 3 SECTION 2. Section 286-116, Hawaii Revised Statutes, is
- 4 amended by amending subsection (a) to read as follows:
- 5 "(a) Every licensee shall have a valid driver's license in
- 6 the licensee's immediate possession at all times, and a valid
- 7 motor vehicle or liability insurance identification card
- 8 applicable to the motor vehicle operated as required under
- 9 section 431:10C-107 and section 431:10G-106, when operating a
- 10 motor vehicle, and shall display the same upon demand of a
- 11 police officer. Every police officer or law enforcement officer
- 12 when stopping a vehicle or inspecting a vehicle for any reason
- 13 shall demand that the driver or owner display the driver's or
- 14 owner's driver's license and insurance identification card.
- 15 Upon demand, the driver or owner may display the driver's
- 16 or owner's electronic motor vehicle insurance identification
- 17 card on a mobile electronic device, as defined in section 291C-
- 18 137. For the purposes of this section, when a person uses a
- 19 mobile electronic device to display an electronic motor vehicle
- 20 insurance identification card to a police officer or law
- 21 enforcement officer, the officer may only view the electronic

- 1 motor vehicle insurance identification card and shall be
- 2 otherwise prohibited from viewing any other content on the
- 3 mobile electronic device. Whenever a person presents a mobile
- 4 electronic device pursuant to this section, that person assumes
- 5 all liability for any damage to the mobile electronic device.
- 6 No person charged with violating this section shall be
- 7 convicted if the person produces in court, or proves from the
- 8 proper official or other records that the person was the holder
- 9 of a driver's license or a motor vehicle or liability insurance
- 10 identification card and policy conforming to article 10C and
- 11 article 10G of chapter 431 or a certificate of self-insurance
- 12 issued by the insurance commissioner pursuant to section
- 13 431:10C-107 and section 431:10G-103, theretofore issued to the
- 14 person and valid at the time of the person's arrest."
- 15 SECTION 3. Section 431:10C-107, Hawaii Revised Statutes,
- 16 is amended by amending subsections (a) and (b) to read as
- 17 follows:
- 18 "(a) Every insurer shall issue to its insureds a paper or
- 19 electronic motor vehicle insurance identification card for each
- 20 motor vehicle for which the basic motor vehicle insurance
- 21 coverage is written. The electronic motor vehicle insurance

- 1 identification card may be accessed directly through the
- 2 licensed insurer's website, application, or database. The
- 3 identification card shall contain the following:
- 4 (1) Name of make and factory or serial number of the motor
- 5 vehicle; provided that insurers of five or more motor
- 6 vehicles which are under common registered ownership
- 7 and used in the regular course of business shall not
- 8 be required to indicate the name of make and the
- 9 factory or serial number of each motor vehicle;
- 10 (2) Policy number;
- 11 (3) Names of the insured and the insurer; and
- 12 (4) Effective dates of coverage including the expiration
- date.
- 14 (b) The identification card shall be in the insured motor
- 15 vehicle or accessible on a mobile electronic device, as defined
- 16 in section 291C-137, at all times and shall be exhibited to a
- 17 law enforcement officer upon demand."
- 18 SECTION 4. Section 431:10G-106, Hawaii Revised Statutes,
- 19 is amended to read as follows:
- 20 "\$431:10G-106 Verification of insurance. Every insurer
- 21 shall issue to each of its insureds a paper or electronic proof

2	a liabili	ty policy under this article is written. The
3	electronic	proof of insurance card may be accessed directly

7		motorcycle or motor scooter; provided that insurers of
8		five or more motorcycles or motor scooters that are

12		serial number of each motorcycle or motor scooter;
13	(2)	Policy number;
14	(3)	Names of the insured and the insurer; and

17	The proof	of insurance card shall be carried on, or accessible
18	on a mobil	le electronic device, as defined in section 291C-137,
19	by the per	rson operating the insured motorcycle or motor scooter
20	at all tir	mes and shall be exhibited to a law enforcement officer

upon demand."

- 2 matured, penalties that were incurred, and proceedings that were
- 3 begun before its effective date.
