A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 302L-1, Hawaii Revised Statutes, is 2 amended as follows:
- 3 1. By adding a new definition to be appropriately
- 4 inserted and to read as follows:
- 5 ""Commission" means the early learning commission
- 6 established pursuant to this chapter."
- 7 2. By repealing the definition of "advisory board".
- 8 ["."Advisory board" means the early learning advisory board
- 9 established pursuant to this chapter."]
- 10 SECTION 2. Section 302L-1.5, Hawaii Revised Statutes, is
- amended by amending subsection (b) to read as follows:
- 12 "(b) The head of the executive office on early learning
- 13 shall be known as the director of the executive office on early
- 14 learning, hereinafter referred to as director. The director
- 15 shall:
- 16 (1) Be appointed by the [governor;] commission;

1	(2)	Have professional training in the field of social
2		work, education, or other related fields;
3	(3)	Have direct experience in programs or services related
4		to early childhood education;
5	(4)	Have recent experience in a supervisory, consultative,
6		or administrative position;
7	(5)	Be paid a salary set by the [governor] commission that
8		shall not exceed ninety per cent of the salary of the
9		director of human resources development; and
10	(6)	Be included in any benefit program generally
11		applicable to the officers and employees of the
12		State."
13	SECT	ION 3. Section 302L-1.6, Hawaii Revised Statutes, is
14	amended t	o read as follows:
15	" [-[]	§302L-1.6[+] Early learning [advisory board.]
16	commissio	n. (a) There is established an early learning
17	[advisory	board, commission, whose members shall be appointed
18	by the go	vernor pursuant to section 26-34. The [advisory board]
19	commissio	n shall be responsible for:

1	(1)	[Advising] Directing the office on how best to meet
2	v.	the educational needs of children, from prenatal care
3		to entry into kindergarten;
4	(2)	[Providing recommendations to] Directing the office on
5		improving the quality, availability, and coordination
6		of early childhood care and education programs;
7	(3)	Promoting collaboration across agencies and
8		stakeholders serving young children; [and]
9	(4)	[Being] Serving as an independent voice for children's
10		health, safety, development, and learning[-]; and
11	<u>(5)</u>	Appointing and dismissing the director of the
12		executive office on early learning, who shall serve at
13		the commission's pleasure.
14	(b)	The [advisory board] commission shall consist of the
15	following	voting members:
16	(1)	A representative of center-based program providers or
17		the representative's designee;
18	(2)	A representative of family child care program
19		providers;
20	(3)	A representative of family-child interaction learning
21		program providers;

1	(4)	A representative of philanthropic organizations that
2		support early learning or the representative's
3		designee;
4	(5)	A representative from a head start provider agency;
5	(6)	A representative from the Hawaii Early Intervention
6		Coordinating Council;
7	(7)	A parent representative;
8	(8)	A representative from the Hawaii chapter of the
9		American Academy of Pediatrics;
10	(9)	A representative of home-visiting program providers;
11	(10)	A representative of Hawaiian medium early learning
12		providers; and
13	(11)	Two representatives of the Hawaii Council of Mayors or
14		each representative's respective designee.
15	The	superintendent of education, director of human
16	services,	director of health, and president of the University of
17	Hawaii sh	all serve as ex officio, voting members of the
18	[advisory	board.] commission.
19	The	[advisory board] commission shall invite the director
20	of the Ha	waii head start state collaboration office, the chief
21	evecutive	officer of Kamehameha Schools and the evecutive

- 2 their designees, to serve as voting members of the [advisory
- 3 board.] commission.
- 4 (c) Except for the superintendent of education, directors
- 5 of state departments, president of the University of Hawaii,

- 7 chief executive officer of Kamehameha Schools, and the executive
- 8 director of the Hawaii Association of Independent Schools, or
- 9 their designees, the members of the [advisory board] commission
- 10 shall serve staggered terms as follows:
- 11 (1) The representative of center-based program providers
- shall serve a two-year term;
- 13 (2) The representative of family child care program
- providers shall serve a three-year term;
- 15 (3) The representative of family-child interaction
- 16 learning program providers shall serve a three-year
- 17 term;
- 18 (4) The representative of philanthropic organizations that
- support early learning shall serve a two-year term;
- 20 (5) The representative from a head start provider agency
- 21 shall serve a three-year term;

3	(7)	The parent representative shall serve a two-year term;
4	(8)	The representative from the Hawaii chapter of the

8		shall serve a three-year term;
9	(10)	The representative of Hawaiian medium early learning
10		providers shall serve a two-year term; and
11	(11)	Of the two representatives of the Hawaii Council of
12		Mayors, one shall serve a two-year term, and the other
13		shall serve a three-year term as determined by the
14		Hawaii Council of Mayors.
15	(d)	The [advisory board] commission shall select a
16	chairpers	on by a majority vote of its members; provided that the
17	chairperson shall be a representative from the private sector.	
18	A majorit	y of the members serving on the [advisory board]
19	commissio	\underline{n} shall constitute a quorum to conduct business. The
20	concurren	ce of the majority of the members serving on the

1	[advisory board] Commission shall be necessary to make any
2	action of the [advisory board] commission valid.
3	(e) The [advisory board] commission may form workgroups
4	and subcommittees, including with individuals who are not
5	[advisory board] commission members, to:
6	(1) Obtain resource information from early learning
7	professionals and other individuals as deemed
8	necessary by the [advisory board;] commission;
9	(2) Make recommendations to the [advisory board;]
10	commission; and
11	(3) Perform other functions as deemed necessary by the
12	[advisory board] commission to fulfill its duties and
13	responsibilities.
14	Two or more [advisory board] commission members, but less
15	than a quorum, may discuss matters relating to official
16	[advisory board] commission business in the course of their
17	participation in a workgroup or subcommittee, and such
18	discussion shall be a permitted interaction as provided for in
19	section 92-2.5.

- 1 (f) The [advisory board] commission may testify before the
- 2 legislature on any matter related to its duties and
- 3 responsibilities.
- 4 (g) Members of the [advisory board] commission shall serve
- 5 without compensation but shall be reimbursed for expenses,
- 6 including travel expenses, necessary for the performance of
- 7 their duties."
- 8 SECTION 4. Section 302L-3.5, Hawaii Revised Statutes, is
- 9 amended to read as follows:
- 10 "§302L-3.5 [Advisory board] Commission meetings by
- 11 teleconference. (a) Notwithstanding any law to the contrary,
- 12 the [advisory board] commission may meet by teleconference.
- 13 (b) Each member of the [advisory board] commission
- 14 participating in a meeting by teleconference shall be considered
- 15 present at the meeting for purposes of determining quorum and
- 16 participating in all proceedings.
- 17 (c) A meeting by teleconference:
- 18 (1) Need not have a quorum present at any one location;
- **19** and
- 20 (2) Is subject to the notice requirements applicable to
- 21 other [advisory board] commission meetings.

- 1 (d) The notice of each teleconference meeting shall
- 2 specify all physical locations from which members of the
- 3 [advisory board] commission will participate. The notice shall
- 4 also specify the physical location from which the presiding
- 5 officer of the [advisory board] commission will preside. All
- 6 physical teleconference locations shall be open to the public
- 7 during the open portion of the meeting.
- 8 (e) [Advisory board] Commission materials that are to be
- 9 considered at the meeting shall be made available at all
- 10 physical teleconference locations.
- 11 (f) Each part of the teleconference meeting that is
- 12 required to be open to the public shall be audible to the public
- 13 at each physical location specified in the notice of the
- 14 meeting.
- (q) Except when voice votes are authorized, the vote shall
- 16 be conducted in such a manner that the public may know the vote
- 17 of each person entitled to vote. The vote at a meeting held by
- 18 teleconference shall be taken by roll call.
- (h) The public shall be allowed to participate and speak
- 20 at a meeting conducted by teleconference in the same manner and

- 1 to the same extent that the public is allowed to participate and
- 2 speak at each physical site of the meeting."
- 3 SECTION 5. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 6. This Act shall take effect on July 1, 2016.
