## A BILL FOR AN ACT

RELATING TO ORAL HEALTH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

T	SECTI	ON 1	. The legislature finds that the State recently
2	received a	ı fai	ling grade in a series of oral health report cards
3	released b	y Th	e Pew Center on the States. The legislature
4	further fi	.nds	that, according to the department of health's
5	Hawaii Ora	al He	alth: Key Findings report released in August 2015:
6	(1)	From	2009 to 2011, only:
7		(A)	Forty-one per cent of all pregnant women;
8		(B)	Twenty-nine per cent of pregnant low-income
9			women; and
10		(C)	Twenty-seven per cent of pregnant women on
11			medicaid or QUEST;
12		visi	ted a dentist during their pregnancy; and
13	(2)	In 2	012:
14		(A)	Only fifty-two per cent of low-income adults saw
15			a dentist, while eighty-two per cent of high-
16			income adults did so;

1	(B)	Fifty-one per cent of low-income adults lost
2		teeth due to dental disease, while only thirty-
3		two per cent of high-income adults did so; and
4	(C)	There were more than three thousand emergency
5		room visits due to preventable dental problems,
6		sixty-seven per cent more than in 2006, and
7		significantly more than the national average. As
8		a result, aggregate hospital charges for dental
9		emergency visits were \$8,500,000, compared to
10		\$4,000,000 in 2006, due in part to the increased
11		number of visits.
12	The legis	lature further finds that these figures represent
13	that oral heal	th in the State is in a pervasive and expensive
14	public health	crisis. The State needs to make a more concerted
15	effort to addr	ess oral health in Hawaii, especially among low-
16	income and und	erserved populations. The legislature further
17	finds that the	department of health has identified multiple key
18	strategies tha	t, if implemented, could improve the oral health
19	of Hawaii's re	sidents. Among these strategies are proposals to:

1	(1) Conclude to support and expand altordable and
2	accessible preventive dental care services to Hawaii'
3	low-income populations; and
4	(2) Expand medicaid dental services for adults beyond the
5	limited current coverage for emergencies to include
6	preventive and treatment services.
7	The legislature further finds that it is in the best
8	interest of the State to expand access to coverage by restoring
9	basic adult dental benefits to medicaid and QUEST integration
10	enrollees. The State's federally matched medicaid and QUEST
11	integration programs form an essential support for underserved
12	individuals by offering insurance options for low-income
13	citizens, in addition to other social service programs. The
14	restoration of basic adult dental benefits would be consistent
15	with the powers and duties of the department of human services.
16	When individuals are no longer burdened by poor oral health,
17	they can eat properly, work more productively, and devote more
18	concentration to everyday tasks.
19	The purpose of this Act is to appropriate funds to restore
20	basic adult dental benefits to medicaid and QUEST integration
21	enrollees.

- 1 SECTION 2. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so much
- 3 thereof as may be necessary for fiscal year 2016-2017 to restore
- 4 basic adult dental benefits to medicaid and Hawaii QUEST
- 5 integration enrollees.
- 6 The sum appropriated shall be expended by the department of
- 7 human services for the purposes of this section; provided that
- 8 the department of human services shall obtain the maximum amount
- 9 of federal matching funds available for this expenditure.
- 10 SECTION 3. This Act shall take effect on July 1, 2112.
