#### A BILL FOR AN ACT

RELATING TO AQUATIC RESOURCES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that traditional Hawaiian 2 stewardship practices include the careful management of ocean and marine life resources. Today, many Hawaiian communities, 3 4 especially in the county of Maui, are revitalizing and 5 implementing traditional marine stewardship, such as at Koʻieʻie 6 fish pond in Kihei and at Ali'i and Kalokoeli fish ponds on 7 Molokai. Despite these efforts to help replenish aquatic life, 8 declines in various marine species have resulted from the taking 9 of excess fish and other aquatic life. Unfortunately, damage to 10 marine resources is often not well documented or understood 11 until irreversible or severe damage occurs. These impacts can 12 be reversed by proactive stewardship. For the sake of 13 preservation of the environment, the economy, and the social and 14 cultural importance to the people of Hawaii and their future 15 generations, the taking of marine life must be regulated. 16 Spearfishing is an ancient method of fishing that has been used 17 throughout the world for millennia; however, spearfishing for

1	commercial purposes does not perpetuate the tradition as		
2	implemented within Hawaiian history and culture.		
3	The purpose of this Act is to prohibit the sale of marine		
4	life that has been secured by the use of a spear.		
5	SECTION 2. Chapter 188, Hawaii Revised Statutes, is		
6	amended by adding two new sections to be appropriately		
7	designated and to read as follows:		
8	" <b>§188- Definitions.</b> As used in this chapter, the		
9	following terms shall have the following respective meanings,		
10	unless the context requires otherwise:		
11	"Aquatic life" means any type or species of mammal, fish,		
12	amphibian, reptile, mollusk, crustacean, arthropod,		
13	invertebrate, coral, or other animal that inhabits the ocean and		
14	freshwater environments.		
15	"Sell" means to transfer, prescribe, give, or deliver to		
16	another, or to offer or agree to do the same to another, for		
17	consideration.		
18	"Speared" means pierced, impaled, penetrated, struck, or		
19	run through by a sharp, pointed implement.

1	"Spearfishing" means fishing by the use of a speargun,			
2	polespear or handspear, Hawaiian sling, elastic-powered speargun			
3	and sling, pneumatic speargun, or mechanically powered speargun.			
4	<u>§188-</u> Selling of aquatic life secured by spearfishing,			
5	prohibited; penalties and fines. (a) It shall be unlawful for			
6	any person at any time to knowingly or intentionally sell or			
7	offer to sell aquatic life acquired by spearfishing and removed			
8	from any of the waters within the jurisdiction of the State.			
9	(b) This section shall not apply to a person exercising a			
10	customary and traditional right for subsistence, cultural, or			
11	religious purposes, subject to the right of the State to			
12	regulate that right, including native Hawaiian gathering rights			
13	and traditional cultural practices as authorized by law or as			
14	permitted pursuant to article XII, section 7, of the Hawaii			
15	state constitution.			
16	(c) This section shall not apply to individuals who			
17	spearfish for personal use, such as for human consumption or for			
18	bait, and have no intention to sell the aquatic life.			
19	(d) Any person who violates this section or any rule			
20	adopted pursuant to this section shall be guilty of a

1	misdemeanor; provided that the fine for violating this section		
2	shall be as follows	<u>:</u>

4	(2) \$2,000 fo	r a second offense; and	
5	<u>(3)</u> <u>\$1</u> 0,000 f	or a third or subsequent offense.	
6	<u>(e) In additi</u>	on to any other penalty imposed under this	
7	section, a person v	iolating this section shall be subject to:	
8	<u>(1)</u> <u>An admini</u>	strative fine of not more than \$1,000 for	
9	each aqua	tic life specimen sold;	
10	<u>(2)</u> Seizure a	nd forfeiture of any taken aquatic life	
11	specimens	, fishing and commercial marine license,	
12	<u>vessel, a</u>	nd equipment; and	
13	(3) Assessmen	t of administrative fees and costs and	
14	attorney'	s fees and costs."	
15	SECTION 3. Th	is Act does not affect rights and duties that	
16	matured, penalties	that were incurred, and proceedings that were	
17	begun before its ef	fective date.	
18	SECTION 4. New statutory material is underscored.
