## A BILL FOR AN ACT

RELATING TO THE WEST MAUI OCEAN RECREATION MANAGEMENT AREA.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that increased
- 2 recreational and commercial activities in Hawaii's nearshore
- 3 waters have led to safety concerns, and in some cases, tragic
- 4 results. The legislature also finds that given the popularity
- 5 of ocean activities in Kaanapali on the island of Maui, the
- 6 department of land and natural resources should establish a west
- 7 Maui ocean recreation management area advisory committee
- 8 comprised of users of the ocean to work with the department on
- 9 issues relating to the area, particularly the waters of
- 10 Kaanapali.
- 11 SECTION 2. (a) Not later than September 1, 2016, the
- 12 department of land and natural resources shall establish a west
- 13 Maui ocean recreation management area advisory committee that
- 14 shall advise the department of land and natural resources on
- 15 issues related to the uses and maintenance of state waters
- 16 within the west Maui ocean recreation management area,

- 1 particularly within the waters adjacent to Kaanapali on the
- 2 island of Maui.
- 3 (b) The advisory committee shall consist of seven members
- 4 of the west Maui community appointed by the chairperson of the
- 5 board of land and natural resources without regard to section
- 6 26-34, Hawaii Revised Statutes, as follows:
- 7 (1) One swimming enthusiast;
- 8 (2) One paddling enthusiast;
- 9 (3) One surfing enthusiast;
- 10 (4) One commercial boating enthusiast;
- 11 (5) One fishing enthusiast;
- 12 (6) One representative of the aha moku advisory committee;
- and
- 14 (7) One commercial operator who holds a permit to operate
- 15 within the west Maui ocean recreation management area.
- 16 No member shall be made subject to chapter 84, Hawaii Revised
- 17 Statutes, solely because of that member's participation as a
- 18 member of the advisory committee. The advisory committee
- 19 created by this section shall be terminated on June 30, 2019.
- 20 SECTION 3. The department of land and natural resources
- 21 shall submit an annual report to the legislature, no later than

- 1 twenty days prior to the convening of each regular session
- 2 beginning with the 2017 regular session and until the expiration
- 3 of the west Maui ocean recreation management area advisory
- 4 committee, regarding the findings and recommendations, including
- 5 any proposed legislation, of the west Maui ocean recreation
- 6 management area advisory committee.
- 7 SECTION 4. This Act shall take effect on December 24,
- 8 2088.
