A BILL FOR AN ACT

RELATING TO THE DIAMOND HEAD STATE MONUMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that Diamond Head is a
2	world-famous landmark, representing Hawaii to millions of people
3	throughout the world. In recognition of Diamond Head's wealth
4	of information about Hawaii's geology, plants, and ancient
5	Hawaiian culture, the legislature adopted Act 104, Session Laws
6	of Hawaii 1976, to establish the Diamond Head State Monument as
7	an historical site on Oahu. Subsequently, the Diamond Head
8	State Monument plan of 1979 established a state policy of
9	establishing a semi-wilderness park with minimal enhancement to
10	Diamond Head. The Diamond Head Citizens Advisory Committee was
11	formed in 1977 to advise the department of land and natural
12	resources on the preservation and management of Diamond Head.
13	Further, Act 313, Session Laws of Hawaii 1992, reaffirmed the
14	recognition of Diamond Head crater as a natural landmark by the
15	federal government and a state monument by the State of Hawaii.
16	The legislature further finds that number of visitors at
17	Diamond Head exceeds one million annually, more than other state

- 1 parks. Therefore, Act 292, Session Laws of Hawaii 2007,
- 2 established within the state parks special fund a Diamond Head
- 3 State Monument sub-account, into which is deposited fifty-five
- 4 per cent of all proceeds collected from the admission fees
- 5 charged at the Diamond Head State Monument. Moneys from the
- 6 sub-account are to be expended on repair, maintenance, and
- 7 operating costs incurred by the State in the management of the
- 8 Diamond Head State Monument.
- 9 The legislature further finds that visitors to the Diamond
- 10 Head State Monument currently use the services of an
- 11 interpretive kiosk. The high number of visitors, however,
- 12 justifies the planning, design, and construction of a dedicated
- 13 visitor and interpretive center, which has been a long-standing
- 14 goal of the Diamond Head State Monument master plan, and which
- 15 can more adequately inform the public and provide educational
- 16 programs about the unique history and significance of Diamond
- 17 Head.
- 18 The purpose of this Act is to support the Diamond Head
- 19 State Monument by:

1	(_)	including appropriacions from the registature as a
2		source from which moneys may be deposited into the
3		state parks special fund;
4	(2)	Increasing the percentage of proceeds collected from
5		the admission fees charged at the Diamond Head State
6		Monument that are deposited into the Diamond Head
7		State Momument sub-account of the state parks special
8		fund from fifty-five per cent to per cent;
9	(3)	Expanding the sources from which moneys shall be
10		deposited into the Diamond Head State Monument sub-
11		account of the state parks special fund;
12	(4)	Authorizing the department of land and natural
13		resources to expend moneys from the Diamond Head State
14		Monument sub-account of the state parks special fund
15		on planning, design, construction, at the Diamond Head
16		State Monument, including the visitor and interpretive
17		center, and educational programs relating to the
18		Diamond Head State Monument; and
19	(5)	Authorizing the issuance of general obligation bonds
20		for the planning, design, and construction of a

1		Diamond Head State Monument visitor and interpretive
2		center.
3	SECT	ION 2. Section 184-3.4, Hawaii Revised Statutes, is
4	amended to	read as follows:
5	"§184	4-3.4 State parks special fund. (a) There is
6	establish	ed within the state treasury a fund to be known as the
7	state par	s special fund, into which shall be deposited:
8	(1)	All proceeds collected by the state parks programs
9		involving park user fees, any leases or concession
10		agreements, the sale of any article purchased from the
11		department to benefit the state parks programs, or any
12		gifts or contributions; provided that proceeds derived
13		from the operation of Iolani Palace shall be used to
14		supplement its educational and interpretive programs;
15		[and]
16	(2)	Transient accommodations tax revenues pursuant to
17		section 237D-6.5; provided that these moneys shall be
18		expended in response to a master plan developed in
19		coordination with the Hawaii tourism authority $[-]$; and
20	<u>(3)</u>	Appropriations by the legislature to the state parks
21		special fund.

1	(b)	The department shall expend the moneys from the state
2	parks spec	cial fund for the following purposes:
3	(1)	Permanent and temporary staff positions;
4	(2)	Planning and development of state parks programs,
5		including the aina hoomalu state parks program;
6	(3)	Construction, repairs, replacement, additions, and
7		extensions of state parks facilities;
8	(4)	Operation and maintenance costs of state parks and
9		state parks programs; and
10	(5)	Administrative costs of the division of state parks.
11	(c)	There is established within the state parks special
12	fund[7] a	Diamond Head State Monument sub-account, into which
13	shall be	deposited [fifty-five] per cent of all proceeds
14	collected	from [the admission]:
15	(1)	Admission and user fees [charged at] and lease and
16		concession agreements involving the Diamond Head State
17		Monument [+] ;
18	(2)	Funds to benefit the Diamond Head State Monument
19		resulting from the sale of any article purchased from
20		the department;
21	(3)	Gifts and contributions; and

1	(4)	Appropriations by the legislature to the Diamond Head
2		State Monument sub-account of the state parks special
3		fund.
4	<u>(d)</u>	The department shall expend the moneys from the
5	Diamond H	ead State Monument sub-account for [repair,]:
6	(1)	Repair, replacement, maintenance, [and] operating, and
7		<pre>management costs;</pre>
8	(2)	Planning, design, construction, and additions; and
9	(3)	Education programs;
10	[incurred	by the State in the management of] relating to the
11	Diamond H	ead State Monument[-], including a visitor and
12	interpret	ive center."
13	SECT	ION 3. The director of finance is authorized to issue
14	general o	bligation bonds in the sum of \$ or so much
15	thereof a	s may be necessary and the same sum or so much thereof
16	as may be	necessary is appropriated for fiscal year 2016-2017
17	for the p	urpose of planning, designing, and constructing a
18	Diamond H	ead State Monument visitor and interpretive center.
19	The	sum appropriated shall be deposited into the Diamond
20	Head Stat	e Monument sub-account of the state parks special fund.

- 13 SECTION 6. This Act shall take effect on July 1, 2016.
