A BILL FOR AN ACT

RELATING TO AGING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that the kupuna care
3	program was enacted in 1999 to address the needs of Hawaii's
4	aging population and the issues arising from those needs. The
5	kupuna care program is considered to be an alternative to
6	traditional long-term care options. The goal of kupuna care is
7	to enable Hawaii seniors to lead independent, meaningful, and
8	dignified lives in their own homes and communities. The
9	legislature further finds that the kupuna care program provides
10	access to affordable and quality home- and community-based
1	services, including hot meals, transportation, case management,
12	and personal care assistance. Services offered by the kupuna
13	care program provide a safety net for all kupuna and their
l 4	caregivers.
15	SECTION 2. There is appropriated out of the general
16	revenues of the State of Hawaii the sum of \$ or so
17	much thereof as may be necessary for fiscal year 2016-2017 for
18	the kupuna care program; provided that the sum appropriated

- 1 shall be in addition to the base budget of the executive office
- 2 on aging.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this part.
- 5 PART II
- 6 SECTION 3. The legislature finds that the State's aging
- 7 and disability resource center is a person-centered process
- 8 intended to navigate and streamline access to long-term supports
- 9 and services for older adults, individuals with disabilities,
- 10 and family caregivers. The legislature additionally finds that
- 11 proper funding for the aging and disability resource center is
- 12 essential to ensure the center is an effective single point of
- 13 entry for individuals seeking information about appropriate
- 14 long-term care options. Ensuring the availability of services
- once a consumer receives a referral, such as those offered
- 16 through the kupuna care program, is also critical to the success
- 17 of the aging and disability resource center.
- 18 SECTION 4. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so
- 20 much thereof as may be necessary for fiscal year 2016-2017 for
- 21 the aging and disability resource center.

- 1 The sum appropriated shall be expended by the department of
- 2 health for the purposes of this part.
- 3 PART III
- 4 SECTION 5. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so
- 6 much thereof as may be necessary for fiscal year 2016-2017 for
- 7 the long-term care ombudsman program to establish three full-
- 8 time equivalent (3.0 FTE) staff positions to monitor the quality
- 9 of long term care in the counties of Kauai, Maui, and Hawaii;
- 10 provided that one position shall serve the county of Kauai, one
- 11 position shall serve the county of Maui, and one position shall
- 12 serve the county of Hawaii.
- 13 The sum appropriated shall be expended by the department of
- 14 health for the purposes of this part.
- 15 PART IV
- 16 SECTION 6. The legislature finds that every year in
- 17 Hawaii, on average eighty-five seniors die, 1,960 are
- 18 hospitalized, and 8,700 are treated in emergency departments as
- 19 a result of falls. Falls among the elderly also result in
- 20 almost \$1,200,000 in hospital and physician charges. In
- 21 recognition of this critical public health issue, Act 153,

- 1 Session Laws of Hawaii 2014, established a fall prevention and
- 2 early detection services coordinator position within the
- 3 department of health's emergency medical services and injury
- 4 prevention system branch. This position enables the department
- 5 of health to support a coordinated statewide approach to prevent
- 6 and reduce the impact of falls among older adults. Act 153
- 7 funded a new position for a fall prevention and early detection
- 8 coordinator for fiscal year 2014 to 2015.
- 9 The legislature further finds that access to fall
- 10 prevention services and programs would significantly reduce
- 11 costs associated with falls in the elderly by expediting
- 12 treatment, minimizing serious long-term consequences, reducing
- 13 the extent of the injury, and in some instances, avoiding death.
- 14 Falls among the elderly are a significant public health
- 15 issue. Yet, currently, there are insufficient resources to
- 16 develop a coordinated statewide approach to reduce and promptly
- 17 detect falls among the elderly. The program serves as a focal
- 18 point for statewide injury prevention and detection efforts to
- 19 ensure multidisciplinary support, coordination of prevention and
- 20 detection efforts, and continuity of implementation and
- 21 accountability.

- 1 The purpose of this part is to assure a continued focus on
- 2 fall prevention in Hawaii, which will ultimately result in
- 3 longer, healthier lives for the State's aging population.
- 4 SECTION 7. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so
- 6 much thereof as may be necessary for fiscal year 2016-2017 for
- 7 fall prevention and early detection services for the elderly.
- 8 The sum appropriated shall be expended by the department of
- 9 health for the purposes of this part.
- 10 PART V
- 11 SECTION 8. The legislature finds that the Hawaii healthy
- 12 aging partnership program was established in 2003 to improve the
- 13 health status of older adults by empowering residents to make
- 14 healthy decisions and engage in healthier lifestyles. Since its
- 15 formation, the healthy aging partnership has successfully
- 16 adapted evidence-based health promotion programs and disease
- 17 prevention programs for the multicultural population in Hawaii.
- 18 The legislature further finds that participants who complete
- 19 workshops offered by the healthy aging partnership feel better,
- 20 are less limited by their health conditions, and often spend
- 21 less time at their doctor's office.

- 1 The legislature also finds that the healthy aging
- 2 partnership received the 2013 Multicultural Aging award from the
- 3 American Society on Aging. This award brought national
- 4 recognition for the healthy aging partnership's critical role in
- 5 improving the health of Hawaii's multiethnic elderly population.
- 6 The purpose of this part is to provide funding to support
- 7 the healthy aging partnership program and its important role in
- 8 improving the health and well-being of Hawaii's kupuna.
- 9 SECTION 9. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$ or so
- 11 much thereof as may be necessary for fiscal year 2016-2017 for
- 12 the healthy aging partnership program of the department of
- 13 health's executive office on aging.
- 14 The sum appropriated shall be expended by the department of
- 15 health for the purposes of this part.
- 16 PART VI
- 17 SECTION 10. The legislature finds that the *Hawaii 2025*:
- 18 State Plan Alzheimer's Disease and Related Dementias, published
- 19 by the executive office on aging, identifies goals and key
- 20 strategies to improve the lives of the numerous families
- 21 affected by the disease. The legislature further finds that

- 1 Alzheimer's disease is the sixth leading cause of death in the
- 2 United States and that it affects twenty-six thousand Hawaii
- 3 residents, a number that will increase by forty per cent by the
- 4 year 2025. The legislature also finds that an estimated sixty-
- 5 five thousand unpaid caregivers in this State provide seventy-
- 6 four million hours of unpaid care each year.
- With the significantly high number of individuals affected
- 8 by Alzheimer's disease as a person having the disease or as a
- 9 caregiver, and the substantial projected increase by 2025, there
- 10 is a need for a coordinated and prepared support system to
- 11 address the multitude of issues arising from addressing the
- 12 disease. While the Hawaii 2025: State Plan Alzheimer's Disease
- 13 and Related Dementias identifies strategies to address the
- 14 disease, the services and activities require coordination at a
- 15 systemic level, such as through a coordinator position.
- 16 The legislature further finds that the public awareness and
- 17 communication subcommittee of the statewide task force on
- 18 Alzheimer's disease and related dementia made the key
- 19 recommendation calling for a public awareness campaign that
- 20 utilizes various media sources to positively promote adults with
- 21 Alzheimer's disease and related dementia with dignity and

- 1 respect and highlight caregivers as compassionate individuals
- 2 who champion the health and well-being of their loved ones.
- 3 The purpose of this part is to make an appropriation for an
- 4 Alzheimer's disease and related dementia services coordinator
- 5 position and to make an appropriation for a campaign to raise
- 6 public awareness about Alzheimer's disease and related dementia.
- 7 SECTION 11. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2016-2017 for
- 10 the Alzheimer's disease and related dementia services
- 11 coordinator position, which shall be exempt from the civil
- 12 service requirements of chapter 76, Hawaii Revised Statutes,
- 13 until July 1, 2018.
- 14 The sum appropriated shall be expended by the department of
- 15 health for the purposes of this part.
- 16 SECTION 12. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2016-2017 for
- 19 an Alzheimer's disease and related dementia public awareness
- 20 campaign that will utilize various media sources to positively
- 21 promote adults with Alzheimer's disease and related dementia

- 1 with dignity and respect and highlight caregivers as

- 4 The sum appropriated shall be expended by the department of
- 5 health for the purposes of this part.

- 7 SECTION 13. This Act shall take effect on July 1, 2070.
