## A BILL FOR AN ACT

RELATING TO INSURANCE COVERAGE OF HEALTH SCREENINGS.

|    | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:         |

| 1  | SECTION 1. The legislature finds that some patients have         |
| 2  | difficulty receiving proper screenings for sexually transmitted  |
| 3  | diseases, including human immunodeficiency virus and acquired    |
| 4  | immunodeficiency syndrome, at annual health screenings. The      |
| 5  | legislature further finds that more than 1,200,000 people in the |
| 6  | United States are living with human immunodeficiency virus and   |
| 7  | almost one in eight affected persons is unaware of the           |
| 8  | infection. It is estimated that, each year, more than fifty      |
| 9  | thousand cases of human immunodeficiency virus are reported with |
| 10 | one in four of the new infections striking those between the     |
| 11 | ages of thirteen and twenty-four.                                |
| 12 | The legislature further finds that early detection of            |
| 13 | sexually transmitted diseases is paramount to proper health care |
| 14 | and prevention of further transmission. The legislature further  |

finds that certain health care providers may not screen 15

specifically for some sexually transmitted diseases, including 16

human immunodeficiency virus and acquired immunodeficiency **17** 

syndrome, at annual screenings, even though the federal Patient

- 10 SECTION 2. Chapter 431, Hawaii Revised Statutes, is
- 11 amended by adding a new section to part I of article 10A to be
- 12 appropriately designated and to read as follows:
- 13 "§431:10A- Human immunodeficiency virus and acquired
- 14 immunodeficiency syndrome screening coverage. (a) Each policy
- 15 of accident and health or sickness insurance issued or renewed
- 16 in this State, except for policies that only provide coverage
- 17 for specified diseases or other limited benefit coverage as
- 18 described in section 431:10A-102.5, shall provide coverage for
- 19 annual screenings for sexually transmitted diseases, including
- 20 screenings for human immunodeficiency virus and acquired
- 21 immunodeficiency syndrome.

- 13 SECTION 6. Notwithstanding any other law to the contrary,
- 14 the coverage for annual screenings of sexually transmitted
- 15 diseases, including screenings for human immunodeficiency virus
- 16 and acquired immunodeficiency syndrome, required under sections
- 17 2, 3, and 4 of this Act shall apply to all health benefits plans
- 18 under chapter 87A, Hawaii Revised Statutes, issued, renewed,
- 19 modified, altered, or amended on or after January 1, 2018.
- 20 SECTION 7. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.

- 1 SECTION 8. This Act shall take effect on July 1, 2016, and
- 2 shall apply to policies, contracts, and plans of health
- 3 insurance issued or renewed after January 1, 2018.

### Report Title:

Women's Caucus; Health Screenings; Health Insurance Coverage; Sexually Transmitted Diseases; Human Immunodeficiency Virus; Acquired Immunodeficiency Syndrome

### Description:

Ensures that all insurers in the State, including health benefits plans under chapter 87A, Hawaii Revised Statutes, provide insurance coverage for sexually transmitted disease screenings, including screenings for human immunodeficiency virus and acquired immunodeficiency syndrome. Applies to health insurance policies, contracts, and plans issued or renewed after January 1, 2018. (HB1897 CD1)
