

### A BILL FOR AN ACT

RELATING TO THE PENAL CODE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 707-750, Hawaii Revised Statutes, is amended by amending the definition of "sexual conduct" in subsection (2) to read as follows:

  ""Sexual conduct" means [acts of] actual or simulated sexual intercourse, including genital-genital contact, oral-genital contact, anal-genital contact, or oral-anal contact,
