#### A BILL FOR AN ACT

RELATING TO TELEHEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that telehealth has
- 2 allowed states to implement innovative health policy reforms
- 3 that achieve significant cost savings and improve health
- 4 outcomes. There are many opportunities for improving health
- 5 care access in Hawaii through the use of telehealth, especially
- 6 in areas of the State faced with a shortage of health care
- 7 providers.
- 8 However, the legislature further finds that restrictions on
- 9 telehealth, such as geographical limitations on service,
- 10 requirements for an established patient-provider relationship or
- 11 a face-to-face examination, limitations on patient setting, and
- 12 restrictions on applicable technology, act as barriers that
- 13 prevent health care providers and patients from realizing the
- 14 full benefits of telehealth.
- Accordingly, the purpose of this Act is to enhance access
- 16 to care via telehealth by:

- 3 digital images and laboratory results for medical interpretation
- 4 and diagnosis, for the purpose of delivering enhanced health
- 5 care services and information while a patient is at an
- 6 originating site and the health care provider is at a distant
- 7 site. Standard telephone contacts, facsimile transmissions, or
- 8 e-mail text, in combination or by itself, does not constitute a
- 9 telehealth service for the purposes of this section."
- 10 SECTION 3. Chapter 671, Hawaii Revised Statutes, is
- 11 amended by adding a new section to be appropriately designated
- 12 and to read as follows:
- 13 "§671- Professional liability insurance; coverage for
- 14 telehealth (a) Every insurer providing professional liability
- 15 insurance for a health care provider shall ensure that every
- 16 policy that is issued, amended, or renewed in this State on or
- 17 after the effective date of this Act shall provide malpractice
- 18 coverage for telehealth that shall be equivalent to coverage for
- 19 the same services provided via face-to-face contact between a
- 20 health care provider and a patient.

1	(b) No insurer providing professional liability insurance
2	policies shall require face-to-face contact between a health
3	care provider and a patient as a prerequisite for coverage of
4	services appropriately provided through telehealth in accordance
5	with generally accepted health care practices and standards
6	prevailing in the applicable professional community at the time
7	the services were provided. The coverage required in this
8	section may be subject to all terms and conditions of the policy
9	agreed upon among the health care provider and the insurer.
10	(c) For purposes of this section:

- 17 telehealth service for the purposes of this section."
- 18 SECTION 4. Section 209E-2, Hawaii Revised Statutes, is
- 19 amended by amending the definition of "medical and health care
- 20 services" to read as follows:

""Medical and health care services" means medical 1 2 research[7] and clinical trials, [and telehealth7] but not 3 routine medical treatment or services." 4 SECTION 5. Section 431:10A-116.3, Hawaii Revised Statutes, 5 is amended to read as follows: 6 "§431:10A-116.3 Coverage for telehealth. (a) It is the 7 intent of the legislature to recognize the application of 8 telehealth as a reimbursable service by which an individual 9 shall receive medical services from a health care provider 10 without face-to-face contact with the provider. 11 (b) No accident and health or sickness insurance plan that 12 is issued, amended, or renewed shall require face-to-face 13 contact between a health care provider and a patient as a 14 prerequisite for payment for services appropriately provided 15 through telehealth in accordance with generally accepted health 16 care practices and standards prevailing in the applicable 17 professional community at the time the services were provided. 18 The coverage required in this section may be subject to all 19 terms and conditions of the plan agreed upon among the enrollee

or subscriber, the insurer, and the provider.

- 16 issued, amended, or renewed shall require face-to-face contact
- 17 between a health care provider and a patient as a prerequisite
- 18 for payment for services appropriately provided through
- 19 telehealth in accordance with generally accepted health care
- 20 practices and standards prevailing in the applicable

- 18 acting within the scope of the physician's license to practice
- 19 from practicing telehealth as defined in this section.
- 20 [(b) For the purposes of this section, "telehealth" means
- 21 the use of telecommunications as that term is defined in section

#### Report Title:

Telehealth; Insurance; Medicaid; Covered Services; Liability Insurance; Reimbursement; Disclosure; Requirements; EUTF

#### Description:

Requires the State's medicaid managed care and fee-for-service programs to cover services provided through telehealth. Specifies medical professional liability insurance policy requirements with regard to telehealth coverage. Clarifies requirements for establishing provider-patient relationships for telehealth for purposes of reimbursement. Specifies reimbursement requirements for distant site and originating site providers. Requires written disclosure of coverages and benefits associated with telehealth services. Ensures telehealth encompasses store and forward technologies, remote monitoring, live consultation, and mobile health. telehealth is covered when originating in a patient's home and other non-medical environments. Clarifies requirements for physicians and out-of-state physicians to establish a physicianpatient relationship via telehealth. Ensures reimbursement requirements for telehealth services apply to all health benefits plans under chapter 87A, Hawaii Revised Statutes. Makes other conforming amendments related to telehealth.
