A BILL FOR AN ACT

RELATING TO ABUSE OF FAMILY OR HOUSEHOLD MEMBER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 709-906, Hawaii Revised Statutes, is amended as follows:

3 1. By amending subsection (1) to read:

"(1) It shall be unlawful for any person, singly or in
concert, to physically abuse a family or household member or to
refuse compliance with the lawful order of a police officer
under subsection (4). The police, in investigating any
complaint of abuse of a family or household member, upon
request, may transport the abused person to a hospital or safe
shelter.

11 For the purposes of this section[, "family]:

"Business day" means any calendar day, except Saturday,
Sunday, or any state holiday.

14 <u>"Family</u> or household member" means spouses or reciprocal 15 beneficiaries, former spouses or reciprocal beneficiaries, 16 persons in a dating relationship as defined under section 586-1, 17 persons who have a child in common, parents, children, persons

15 SECTION 4. This Act shall take effect upon its approval.
