A BILL FOR AN ACT

RELATING TO SUSTAINABILITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that as an island state,
- 2 Hawaii has limited access to natural fresh water supplies. Amid
- 3 increasing population and development, sustainable access to
- 4 fresh water is key to the State's future, and new and innovative
- 5 options for water reclamation must be explored.
- 6 The purpose of this Act is to require the Kaho'olawe island
- 7 reserve commission, in conjunction with the department of
- 8 business, economic development, and tourism, to promote
- 9 photovoltaic powered desalinization on the island of Kaho'olawe
- 10 and to study the benefits of the technology's use.
- 11 SECTION 2. (a) The Kaho'olawe island reserve commission,
- 12 in conjunction with the department of business, economic
- 13 development, and tourism, shall implement a photovoltaic powered
- 14 desalinization pilot project that shall:
- 15 (1) Promote the use of photovoltaic powered desalinization
- on the island of Kahoʻolawe; and
- 17 (2) Study the following aspects of the technology's use:

1	(A) Efficiency and cost-saving opportunities;
2	(B) Conservation, sustainable-development, and water
3	security benefits; and
4	(C) Potential for technological development and
5	future statewide implementation.
6	(b) The pilot project shall commence on July 1, 2017, and
7	shall terminate on June 30, 2020.
8	(c) The Kahoʻolawe island reserve commission, in
9	conjunction with the department of business, economic
10	development, and tourism, shall submit an annual report of its
11	findings and recommendations, including any proposed
12	legislation, to the legislature no later than twenty days prior
13	to the convening of each regular session beginning with the
14	regular session of 2018 and ending with the regular session of
15	2020.
16	SECTION 3. There is appropriated out of the general
17	revenues of the State of Hawaii the sum of \$500,000 or so much
18	thereof as may be necessary for fiscal year 2016-2017 for the
19	purposes of establishing and implementing a three-year
20	photovoltaic powered desalinization pilot project.

The sum appropriated shall be expended by the Kaho'olawe
island reserve commission for the purposes of this Act.

SECTION 4. This Act shall take effect on July 1, 2016.
