A BILL FOR AN ACT

RELATING TO THE WORLD CONSERVATION CONGRESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the International
- 2 Union for Conservation of Nature World Conservation Congress
- 3 meeting will take place in Hawaii from September 1 to 10, 2016,
- 4 and offers a unique opportunity to highlight Hawaii's
- 5 environmental and natural resources as a showcase for the United
- 6 States to share with the world. This is the first time that the
- 7 Congress will convene in the United States. The meeting will
- 8 enhance natural resource conservation not only in Hawaii but
- 9 throughout the world.
- 10 The legislature further finds that the International Union
- 11 for Conservation of Nature is a leading authority on the
- 12 environment and sustainable development. The World Conservation
- 13 Congress consists of more than one thousand two hundred member
- 14 organizations including over two hundred governments, nine
- 15 hundred non-government organizations, and eighty-five member
- 16 organizations in the United States. More than eight thousand
- 17 delegates from over one hundred sixty countries are expected to
- 18 attend the meeting in Hawaii.

- 1 The purpose of this Act is to appropriate funds to the
- 2 department of land and natural resources for the purpose of
- 3 hosting the 2016 International Union for Conservation of Nature
- 4 World Conservation Congress.
- 5 SECTION 2. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$4,000,000 or so much
- 7 thereof as may be necessary for fiscal year 2015-2016 for the
- 8 purpose of hosting the 2016 International Union for Conservation
- 9 of Nature World Conservation Congress meeting at the Hawaii
- 10 Convention Center from September 1 to 10, 2016; provided that
- 11 this appropriation shall not lapse at the end of the fiscal year
- 12 2015-2016; provided further that all moneys that are
- 13 unencumbered as of June 30, 2017, shall lapse as of that date.
- 14 The sum appropriated shall be expended by the department of
- 15 land and natural resources for the purposes of this Act.
- 16 SECTION 3. This Act shall take effect upon its approval.
