A BILL FOR AN ACT

RELATING TO THE WORLD CONSERVATION CONGRESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the International 2 Union for Conservation of Nature World Conservation Congress meeting will take place in Hawaii from September 1 to 10, 2016, 3 4 and offers a unique opportunity to highlight Hawaii's 5 environmental and natural resources as a showcase for the United 6 States to share with the world. This is the first time that the Congress will convene in the United States. The meeting will 7 8 enhance natural resource conservation not only in Hawaii but 9 throughout the world. Specifically, the meeting gives the State an opportunity to highlight its progress toward the six 10 11 sustainability targets of the Aloha+ Challenge and its efforts to mitigate the impacts of invasive species. The State also has 12 the opportunity to highlight the success and ongoing efforts of 13 Hawaii's private sector, including organizations like the Blue 14 Planet Foundation, who advocate for clean energy and convene 15 industry decision makers, policy experts, and community leaders 16 to collaborate on forward-thinking solutions that enable clean 17 In addition, having financial support 18 energy transformation.

- 1 from the community that will follow the leadership and
- 2 initiative of entities, like the Office of Hawaiian Affairs,
- 3 Hau'oli Mau Loa Foundation, and Harold K.L. Castle Foundation,

- 14 Congress consists of more than one thousand two hundred member
- 15 organizations including over two hundred governments, nine
- 16 hundred non-government organizations, and eighty-five member
- 17 organizations in the United States. More than eight thousand
- 18 delegates from over one hundred sixty countries are expected to
- 19 attend the meeting in Hawaii.
- The purpose of this Act is to appropriate funds to the
- 21 department of land and natural resources for the purpose of

- 3 SECTION 2. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2016-2017 for
- 6 the purpose of hosting the 2016 International Union for
- 7 Conservation of Nature World Conservation Congress meeting at
- 8 the Hawaii Convention Center from September 1 to 10, 2016;
- 9 provided that no funds appropriated under this section shall be
- 10 expended unless the state funds are matched on a
- 11 basis with private funds.
- 12 The sum appropriated shall be expended by the department of
- 13 land and natural resources for the purposes of this Act.
- 14 SECTION 3. This Act shall take effect on July 1, 2050.
