A BILL FOR AN ACT

RELATING TO WATER SECURITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The 2016 Hawaii-hosted World Conservation
3	Congress presents an opportunity for Hawaii to demonstrate
4	international leadership in investing in natural capital that
5	supports economic growth and protects the quality of life. The
6	challenge of managing the State's limited natural resources such
7	as watersheds, marine habitat, and fresh water supply while
8	fostering community resilience is too large a task for a single
9	actor or sector to address alone. New and innovative
10	partnerships are needed to catalyze large-scale investment in
11	Hawaii's sustainable development. The Aloha+ Natural Capital
12	Investment Partnership is a joint public-private conservation
13	commitment that will demonstrate Hawaii's commitment to natural
14	resources management with a special focus on climate resilience
15	at the World Conservation Congress and beyond.
16	To provide reliable long-term funding needed to meet the
17	State's Aloha+ Challenge conservation targets by 2030, partners

- 1 from multiple sectors, including county, state, and federal
- 2 governments as well as private philanthropic and corporate
- 3 entities, must work together to leverage funds and provide
- 4 matching opportunities.
- 5 The purpose of this Act is to establish a two-year pilot
- 6 program for a water security advisory group to enable public-
- 7 private partnerships that increase water security by providing
- 8 matching state funds for projects and programs that:
- 9 (1) Increase the recharge of groundwater resources;
- 10 (2) Encourage the reuse of water and reduce the use of
- 11 potable water for landscaping irrigation; and
- 12 (3) Improve the efficiency of potable and agricultural
- water use.
- 14 PART II
- 15 SECTION 2. The department of land and natural resources
- 16 shall establish a two-year pilot program for a water security
- 17 advisory group to enable public-private partnerships that
- 18 increase water security by providing matching state funds for
- 19 projects and programs that:
- 20 (1) Increase the recharge of groundwater resources;

- (2) Encourage the reuse of water and reduce the use of
 potable water for landscaping irrigation; and
- 3 (3) Improve the efficiency of potable and agricultural4 water use.
- 5 SECTION 3. The department of land and natural resources
- 6 may establish an account or fund pursuant to section 37-52.5,
- 7 Hawaii Revised Statutes, into which shall be deposited:
- 8 (1) All moneys appropriated by the legislature;
- 9 (2) Gifts, grants, and other private funds; and
- 10 (3) Federal funds.
- 11 The moneys in the fund shall be used to fund priority projects
- 12 and programs to increase water security recommended by the water
- 13 security advisory group, provided that state funds are matched
- 14 on a one-for-one matching basis by the public or private agency
- 15 or organization that submitted the relevant proposal for a
- 16 project or program to increase water security.
- 17 SECTION 4. The department of land and natural resources
- 18 may contract with an independent non-profit entity to carry out
- 19 the duties and activities associated with this Act.

1	SECT	ION 5. The department of land and natural resources
2	shall est	ablish a water security advisory group, not subject to
3	section 2	6-34, Hawaii Revised Statutes, which shall consist of:
4	(1)	The manager and chief engineer of the board of water
5		supply of each county of the State;
6	(2)	The deputy director for water resource management of
7		the department of land and natural resources;
8	(3)	A member with knowledge of agricultural water storage
9		and delivery systems selected by the chairperson of
10		the board of land and natural resources;
11	(4)	A member from a private landowning entity that
12		actively partners with a watershed partnership
13		selected by the chairperson of the board of land and
14		natural resources;
15	(5)	A member with knowledge, experience, and expertise in
16		the area of Hawaiian cultural practices selected by
17		the chairperson of the board of land and natural
18		resources; and
19	(6)	A member representing a conservation organization
20		selected by the chairperson of the board of land and
21		natural resources.

- 1 The water security advisory group shall elect a chairperson
- 2 from among its members. Any action of the advisory group shall
- 3 be by a simple majority of its members. Five members shall
- 4 constitute a quorum.
- 5 SECTION 6. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so much
- 7 thereof as may be necessary for fiscal year 2016-2017 to carry
- 8 out the purposes of this Act.
- 9 The sum appropriated shall be expended by the department of
- 10 land and natural resources.
- 11 PART III
- 12 SECTION 7. (a) The water security advisory group shall
- 13 advise the department of land and natural resources on the
- 14 priority of all proposals for projects or programs submitted by
- 15 public or private agencies or organizations to increase water
- 16 security in the State and recommend high-priority programs for
- 17 the award of matching funds through the pilot program
- 18 established pursuant to this Act.
- 19 The water security advisory group shall:
- 20 (1) Establish criteria for the evaluation of proposals and
- 21 assignment of priority to proposals;

- 2 (3) Assign priorities to each proposal submitted; and
- 3 (4) Advise the department on its evaluation of and
- 4 assignment of priority to each proposal submitted.
- 5 (b) In advising the department on the priorities for
- 6 matching fund grants for projects and programs to increase water
- 7 security, the water security advisory group shall consider
- 8 projects and programs that:
- 9 (1) Establish new areas or increase existing areas for the recharge of groundwater resources;
- 11 (2) Reduce the use of potable water for landscape12 irrigation and encourages the reuse of water; and
- (3) Improve the efficiency of potable domestic water or
 agricultural irrigation use.
- (c) All projects and programs recommended for approval by

the advisory group shall be required to track and report on the

- 17 amount of water conserved, recharged, or reused by the projects
- 18 and programs.

- 19 SECTION 8. The department of land and natural resources
- 20 shall submit an annual report on the pilot program established
- 21 pursuant to this Act to the governor and the legislature at

1	least twe	enty days prior to the convening of the 2017 and 2018
2	regular l	egislative sessions. The annual reports shall include:
3	(1)	A summary of all the projects and programs approved to
4		increase water security by improving recharge of
5		groundwater, reducing the use of potable water for
6		irrigation, or encouraging reuse of water;
7	(2)	Proposals for future projects and programs;
8	(3)	A financial report for the preceding fiscal year; and
9	(4)	Objectives and budget projections for the following
10		fiscal year.
11	SECI	TION 9. Members of the water security advisory group
12	shall ser	rve without compensation. All necessary expenses of
13	each memb	per, including travel expenses, shall be paid by the
14	agency, c	organization, or department which the member represents.
15	No member	shall be made subject to chapter 84, Hawaii Revised
16	Statutes,	solely because of that member's participation as a
17	member of	the advisory group.
18	SECT	CION 10. The last contract for a project or program
19	recommend	ded for approval by the water security advisory group
20	ghall be	executed before Tune 20, 2019

4	(1)	All contracts, agreements, permits, or other documents
5		executed or entered into by the department of land and
6		natural resources pursuant to this Act shall remain in

9		document; and
10	(2)	All unexpended and unencumbered moneys remaining in ar
11		account or fund established pursuant to section 3 and
