## A BILL FOR AN ACT

RELATING TO COMMUNITY IMPROVEMENT DISTRICTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a lack of affordable
- 2 housing has begun to exacerbate high housing costs and has begun
- 3 to leave Hawaii's residents without a place to call home. It is
- 4 estimated that more than 6,000 new units are needed annually to
- 5 keep pace with current demand.
- 6 The legislature also finds that the Kapalama and Iwilei
- 7 areas are ideal for a 21st century community that encourages
- 8 walking, biking, and rail transit in close proximity to the
- 9 urban core. The San Antonio Riverwalk and Denver's 16th Street
- 10 pedestrian mall, featuring mixed-use restaurants, commercial
- 11 spaces, and residences along pedestrian and bike-friendly
- 12 promenades, have proven a popular and successful way to create
- 13 people-friendly communities to house local residents in an urban
- 14 setting. These successes can also apply here.
- 15 With rail transit soon to come through the area, interest
- 16 rates at an advantageous low, and the growing need for
- 17 affordable rental housing, the legislature finds that aligning

- 7 connect Kapalama Canal with Fort Street Mall, providing safe and
- 8 comfortable pedestrian and bicycle transit to the downtown core.
- 9 (e) The department of accounting and general services and

- 11 infrastructure improvements within the Kapalama community
- 12 improvement district in order that units may be occupied by not
