A BILL FOR AN ACT

RELATING TO CAMPAIGN FINANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 11-381, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) Campaign funds may be used by a candidate, treasurer
4	or candidate committee:
5	(1) For any purpose directly related:
6	(A) In the case of the candidate, to the candidate's
7	own campaign; or
8	(B) In the case of a candidate committee or treasure
9	of a candidate committee, to the campaign of the
10	candidate, question, or issue with which they ar
11	directly associated;
12	(2) To purchase or lease consumer goods, vehicles,
13	equipment, and services that provide a mixed benefit
14	to the candidate. The candidate, however, shall
15	reimburse the candidate's candidate committee for the
16	candidate's personal use of these items unless the
17	personal use is de minimis;

16	of such a	candidate, may use campaign funds as provided in
17	section 1	1-381 or return funds to contributors until four years
18	from the	date of the election for which the campaign funds were
19	received.	Funds that are not used or returned to contributors
20	shall esc	heat to the Hawaii election campaign fund.

- 1 [(d)] (e) A candidate who loses an election and the
- 2 candidate committee of such a candidate may use campaign funds
- 3 as provided in section 11-381 or return funds to contributors
- 4 until one year from the date of the election for which the
- 5 campaign funds were received. Funds that are not used or
- 6 returned to contributors shall escheat to the Hawaii election
- 7 campaign fund.
- 8 [(e)] (f) A candidate committee that disposes of campaign
- 9 funds pursuant to this section shall terminate its registration
- 10 with the commission as provided in section 11-326.
- 11 [(f)] (g) Notwithstanding any of the foregoing, campaign
- 12 funds may be used for the candidate's next subsequent election
- 13 as provided in section 11-381 upon registration for the election

- 17 SECTION 3. Section 11-421, Hawaii Revised Statutes, is

- "(c) Moneys in the fund shall be paid to candidates by the
- 20 comptroller as prescribed in section 11-431 [and-may be used for

- 1 the commission's operating expenses, including staff-salaries
- 2 and fringe-benefits]."
- 3 SECTION 4. The legislature determines that there is in the
- 4 campaign spending trust fund at least \$495,506 in excess of the
- 5 requirements of the fund. Until June 30, 2017, the director of
- 6 finance is authorized to transfer from the campaign spending
- 7 trust fund to the general fund the sum of \$495,506 or so much
- 8 thereof as may be necessary for fiscal year 2016-2017.
- 9 SECTION 5. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$495,506 or so much
- 11 thereof as may be necessary for fiscal year 2016-2017 for the
- 12 campaign spending commission's operating expenses, including
- 13 staff salaries.
- 14 The sum appropriated shall be expended by the campaign
- 15 spending commission for the purposes of this Act.
- 16 SECTION 6. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 7. This Act shall take effect on July 1, 2016.

Report Title:

Campaign Finance; Permissible Uses of Campaign Funds; Campaign Spending Commission; Operating Expenses; Appropriation

Description:

Amends the permitted uses of campaign funds to include private schools as an entity to which a candidate may make a donation up to certain contribution amounts and include expenses incurred for membership in civic or community groups or for protocol gifts as payment of ordinary and necessary expenses incurred in connection with the candidate's duties as a holder of office. Allows a candidate committee of a candidate who ceases to be candidate because of death of the candidate to use campaign funds to make donations to certain types of organizations, return the residual funds to the contributors, or both, within a ninety-day period, and requires any campaign funds not donated or returned to contributors to escheat to the Hawaii election campaign fund. Repeals the use of Hawaii election campaign funds for the operating expenses of the campaign spending commission. Transfers excess trust funds to the general fund. Appropriates moneys to the Campaign Spending Commission for operating expenses. (SD1)
