BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 431, Hawaii Revised Statutes, is
2	amended by adding a new section to article 10A to be

5	(a) Each individual and group accident and health or sickness

12	(b) Every insurer shall provide written notice to its
13	policyholders regarding the coverage required by this section.
14	The notice shall be in writing and prominently positioned in any
15	literature or correspondence sent to policyholders and shall be
16	transmitted to policyholders within calendar year 2017 when
17	annual information is made available to policyholders or in any

- 3 (c) Coverage under this section may be subject to

- 19 (a) Each individual and group hospital or medical service plan
- 20 contract issued or renewed in this State after December 31,
- 21 2016, shall provide to the member and individuals under twenty-

- 4 (b) Every mutual benefit society shall provide written

- 20 SECTION 6. This Act shall take effect on July 1, 2070.
