### A BILL FOR AN ACT

RELATING TO RAT LUNGWORM DISEASE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 health has reported over seventy cases of rat lungworm disease
- 3 caused by Angiostrongylus cantonensis from 2001 to 2014. There
- 4 have been many more cases in 2015, including at least two on
- 5 Maui. The disease has claimed lives and caused crippling
- 6 chronic disability. The cost for one severe case can exceed
- 7 \$1,000,000. The Hawaii island rat lungworm disease working
- 8 group has been formed at the Daniel K. Inouye college of
- 9 pharmacy at the University of Hawaii at Hilo and has been
- 10 conducting research and educational outreach on the disease for
- 11 the past four years.
- 12 The purpose of this Act is to appropriate funds to the
- 13 University of Hawaii at Hilo, the department of health, and the
- 14 department of land and natural resources for programs, studies,
- 15 and activities related to the prevention and eradication of rat
- 16 lungworm disease.

13		available filters and ultraviolet systems to determine
14		effectiveness in catchment;
15	(4)	Optimizing existing tests or developing new blood-
16		based tests for rat lungworm diagnostics;
17	(5)	Developing an integrated pest management plan for best
18		practices for control of rat lungworm hosts and
19		providing that information to the public;
20	(6)	Developing a rural health educational outreach program
21		for rainwater catchment users;

- 8 revenues of the State of Hawaii the sum of \$200,000 or so much
- 9 thereof as may be necessary for fiscal year 2016-2017 for
- 10 activities relating to the prevention and eradication of rat
- 11 lungworm disease, including, together with the University of
- 12 Hawaii at Hilo and the department of health, providing
- 13 educational outreach materials for the general public and Hawaii
- 14 health care providers.
- 15 The sum appropriated shall be expended by the department of
- 16 land and natural resources for the purposes of this Act.
- 17 SECTION 5. This Act shall take effect on July 1, 2016.
