
A BILL FOR AN ACT

RELATING TO LANGUAGE ACCESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 217, Session Laws of Hawaii 2013,
2 appropriated funds for the establishment of a statewide language
3 access resource center within the office of language access to
4 allow state agencies and covered entities to provide
5 interpretation and translation services to limited English
6 proficient individuals. Act 217 also appropriated funds for the
7 establishment of a multilingual website pilot project within the
8 office of language access to enable limited English proficient
9 individuals to obtain information about government services in
10 their language.

11 The statewide language access resource center and the
12 multilingual website pilot project provide meaningful access to
13 important state and state-funded benefits and services to
14 persons who have a limited ability to read, write, speak, or
15 understand English. Both resources have also helped reduce
16 barriers for limited English proficient persons in various
17 areas, including understanding and exercising important rights,



1 complying with applicable responsibilities, and understanding
2 other information provided by state-funded programs and
3 activities.

4 The legislature finds that while Act 217 appropriated
5 funding to establish the statewide language access resource
6 center and the multilingual website pilot project, more funding
7 is necessary to maintain and continue the services of the center
8 and project. Despite advance preparation by the office of
9 language access, implementation of the pilot project was delayed
10 due to unforeseen challenges associated with the transfer of the
11 office of language access as an administrative attachment of the
12 department of labor and industrial relations to the department
13 of health.

14 However, the legislature finds that despite funding and
15 staffing challenges, the office of language access used its
16 limited resources creatively to get the statewide language
17 access resource center off to a firm start. By contracting with
18 a public vendor and working with volunteer members of the
19 language access advisory council, the publicly available roster
20 of language service providers is almost complete. An outside
21 vendor is also beginning work on the multilingual website



1 project. The legislature recognizes the need for permanent
2 staffing and funding to support the statewide language access
3 resource center's opening and operation so that the center can
4 build on the work it has started.

5 The purpose of this Act is to support ongoing efforts to
6 improve access to government services and programs for limited
7 English proficient individuals by appropriating funds to further
8 develop the statewide language access resource center and
9 multilingual website pilot project.

10 SECTION 2. There is appropriated out of the general
11 revenues of the State of Hawaii the sum of \$300,000 or so much
12 thereof as may be necessary for fiscal year 2016-2017 to operate
13 the statewide language access resource center within the office
14 of language access to allow state agencies and covered entities
15 to provide interpretation and translation services to limited
16 English proficient individuals in accordance with Hawaii's
17 language access laws.

18 The sum appropriated shall be expended by the department of
19 health for the purposes of this Act.

20 SECTION 3. There is appropriated out of the general
21 revenues of the State of Hawaii the sum of \$150,000 or so much

1 thereof as may be necessary for fiscal year 2016-2017 to operate
 2 the multilingual website pilot project within the office of
 3 language access to enable limited English proficient individuals
 4 to obtain information about government services in their own
 5 language.

6 The sum appropriated shall be expended by the department of
 7 health for the purposes of this Act.

8 SECTION 4. This Act shall take effect on July 1, 2016.
