RELATING TO GOVERNMENTAL TRAVEL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 78, Hawaii Revised Statutes, is amended
2	by adding a new section to be appropriately designated and to
3	read as follows:
4	"§78- Payment of approved travel costs for public
5	officers and employees. (a) This section shall apply to all
6	approved travel costs incurred by an officer or employee of the
7	State or a county thereof in connection with the official
8	business of the respective jurisdiction.
9	(b) Subject to subsection (d), the State and the several
10	counties shall pay approved travel costs directly to:
11	(1) The vendor providing the goods or services involved;
12	<u>or</u>
13	(2) The officer or employee for whom the approved travel
14	costs are to be paid, by way of a cash advance prior
15	to the date of purchase.
16	(c) This section shall not be construed as precluding the
17	reimbursement of approved travel costs to an officer or employee

- 1 upon completion of travel for any costs that for any reason were
- 2 not paid by the State or the county, as applicable, in
- 3 accordance with subsection (a).
- 4 (d) As pertains to the officer or employee incurring
- 5 approved travel costs, whenever there is a conflict between a
- 6 collective bargaining agreement and any provision of this
- 7 section, the terms of the collective bargaining agreement shall
- 8 prevail.
- 9 (e) For the purposes of this section, "approved travel
- 10 costs" means any determinable costs of travel for official state
- 11 or county business approved by the respective jurisdiction and
- 12 supported by a written invoice. The term includes the costs of
- 13 transportation to and from a destination point, between
- 14 destination points, or within a destination point; event
- 15 registration fees; per diem allowances; and any other necessary
- 16 costs related to the travel."
- 17 SECTION 2. Section 46-25.5, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "[+] §46-25.5[+] Expenses. Subject to section 78- and
- 20 procedures prescribed by the director of finance of the county
- 21 and approved by the mayor, all officers and employees of each



- 1 county shall be entitled to travel or other necessary expenses
- 2 in the performance of their official duties as provided by
- 3 ordinance."
- 4 SECTION 3. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 4. This Act shall take effect on July 1, 2016.
