

### A BILL FOR AN ACT

RELATING TO GOVERNMENTAL TRAVEL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 78, Hawaii Revised Statutes, is amended
2	by adding a new section to be appropriately designated and to
3	read as follows:
4	"§78- Payment of approved travel costs for public
5	officers and employees. (a) This section shall apply to all
6	approved travel costs incurred by an officer or employee of the
7	State or a county in connection with the official business of
8	the respective jurisdiction.
9	(b) Subject to subsection (d), the State and the counties
10	shall pay approved travel costs directly to:
11	(1) The vendor providing the goods or services involved;
12	or
13	(2) The officer or employee for whom the approved travel
14	costs are to be paid, by way of a cash advance prior
15	to the date of purchase.
16	(c) This section shall not be construed as precluding the
17	reimbursement of approved travel costs to an officer or employee

1	upon completion of travel for any costs that for any reason were
2	not paid by the State or the county, as applicable, in
3	accordance with subsection (a).
4	(d) As pertains to the officer or employee incurring
5	approved travel costs, whenever there is a conflict between a
6	collective bargaining agreement and this section, the terms of
7	the collective bargaining agreement shall prevail.
8	(e) For the purposes of this section, "approved travel
9	costs" means any determinable costs of travel for official state
10	or county business approved by the respective jurisdiction and
11	supported by a written invoice. The term includes the costs of
12	transportation to and from a destination point, between
13	destination points, or within a destination point; event
14	registration fees; per diem allowances; and any other necessary
15	costs related to the travel."
16	SECTION 2. Section 46-25.5, Hawaii Revised Statutes, is
17	amended to read as follows:
18	"[+]§46-25.5[+] Expenses. Subject to section 78- and
19	procedures prescribed by the director of finance of the county
20	and approved by the mayor, all officers and employees of each
21	county shall be entitled to travel or other necessary expenses
