# <u>H</u>.B. NO.<u>2272</u>

### A BILL FOR AN ACT

RELATING TO THE BIOSECURITY PROGRAM.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that biosecurity is an 2 overarching issue that requires cooperation and collaboration by 3 numerous parties in order to be addressed properly and to ensure 4 the protection of our environment, community, and local 5 agriculture.

6 The legislature finds that the department of agriculture 7 has multiple duties and activities that address the issue of 8 biosecurity and that initiatives to improve Hawaii biosecurity 9 go beyond the confines of any one branch within the department, 10 and often including other groups both inside and outside of 11 state government.

Groups that positively contribute to Hawaii biosecurity efforts include, but are not limited to, the Hawaii invasive species council, department of land and natural resources, United States Department of Agriculture, coordinating group on alien pest species, and private companies that utilize best management practices when transporting products and equipment throughout the State.

1	The purpose of this act is to establish the biosecurity
2	program as the responsibility of the department of agriculture
3	rather than a branch of the department to enable the program to
4	address biosecurity issues across the entire department.
5	SECTION 2. Chapter 141, Hawaii Revised Statutes, is
6	amended by adding a new part to be appropriately designated and
7	to read as follows:
8	"PART . BIOSECURITY PROGRAM
9	§141-A Biosecurity program; establishment. The department
10	shall establish a biosecurity program authorized under this
11	chapter that shall operate in conjunction with other relevant
12	state agencies and laws.
13	<b>§141-B Objectives of biosecurity program.</b> The objectives
14	of the biosecurity program shall be to:
15	(1) Establish a multi-dimensional system to prevent the
16	entry into the State and interisland movement of
17	pests, prohibited animals, or restricted organisms
18	without a permit; and
19	(2) Respond effectively to eradicate, control, reduce, and
20	suppress incipient pest populations and established
21	pests and seize and dispose of prohibited animals or
22	restricted organisms without a permit.

1 (b) The department shall set the charges at amounts 2 intended to generate revenues that, when combined with federal 3 and other funds, are sufficient to pay for the operating and 4 maintenance cost of the program and debt service on bonds issued 5 to fund facilities constructed for the program.

§141-E Federal and other funds. The department shall
place high priority on seeking and applying for federal and
other funds for the biosecurity program.

9 **§141-F Annual report**. The department shall submit an 10 annual report on the biosecurity program to the legislature no 11 later than twenty days prior to the convening of each regular 12 session of the legislature."

13 SECTION 3. Chapter 150A, part VI, Hawaii Revised Statutes,14 is repealed.

15 SECTION 4. This Act, upon its approval, shall take effect16 on July 1, 2016.

PURPOSE:	To establish the Hawaii biosecurity program as a responsibility of the entire Department of Agriculture, instead of it being solely a Plant Quarantine Branch function.		
MEANS :	Amend chapter 141, Hawaii Revised Statutes, by adding a new part that contains the provisions currently in part VI, chapter 150A, and repeal chapter 150A, part VI, Hawaii Revised Statutes.		
JUSTIFICATION:	As invasive species continue to enter and move throughout the State, biosecurity needs to be realized as an overarching issue that requires cooperation and collaboration by numerous parties in order to be addressed properly and to insure the protection of our environment, community, and local agriculture.		
	The Department of Agriculture has multiple duties and activities that address the issue of biosecurity. Initiatives to improve Hawaii biosecurity go beyond the confines of the Plant Quarantine Branch and often include other groups both inside and outside of state government.		
	Impact on the public: Would provide further protection from the spread of invasive species and agricultural pests in Hawaii through a more inclusive approach to securing the Hawaii biosecurity program.
