RELATING TO PHYSICIAN DISCIPLINE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	<u>(3)</u>	Any request for a hearing shall be made in writing and
2		filed with the board within twenty days after mailing
3		of the proposed order to the licensee; and

7		imposing the disciplinary action described in the
8		proposed order.

7	any licen	se to	practice medicine and surgery may be revoked,
8	limited,	or su	spended by the board at any time in a proceeding
9	before th	e boa	rd, or may be denied, for any cause authorized by
10	law, incl	uding	but not limited to the following:
11	(1)	Proc	uring, or aiding or abetting in procuring, a
12		crim	inal abortion;
13	(2)	Empl	oying any person to solicit patients for one's
14		self	;
15	(3)	Enga	ging in false, fraudulent, or deceptive
16		adve	rtising, including but not limited to:
17		(A)	Making excessive claims of expertise in one or
18			more medical specialty fields;
19		(B)	Assuring a permanent cure for an incurable

1	(9)	Conduct or practice contrary to recognized standards
2		of ethics of the medical profession as adopted by the
3		Hawaii Medical Association, the American Medical
4		Association, the Hawaii Association of Osteopathic
5		Physicians and Surgeons, or the American Osteopathic
6		Association;
7	(10)	Violation of the conditions or limitations upon which
8		a limited or temporary license is issued;
9	(11)	Revocation, suspension, or other disciplinary action
10		by another state or federal agency of a license,
11		certificate, or medical privilege [for reasons as
12		provided in this section];
13	(12)	Conviction, whether by nolo contendere or otherwise,
14		of a penal offense substantially related to the
15		qualifications, functions, or duties of a physician or
16		osteopathic physician, notwithstanding any statutory
17		provision to the contrary;
18	(13)	Violation of chapter 329, the uniform controlled
19		substances act, or any rule adopted thereunder except
20		as provided in section 329-122;

1	(14)	railure to report to the board, in writing, any
2		disciplinary decision issued against the licensee or
3		the applicant in another jurisdiction within thirty
4		days after the disciplinary decision is issued; or
5	(15)	Submitting to or filing with the board any notice,
6		statement, or other document required under this
7		chapter, which is false or untrue or contains any
8		material misstatement or omission of fact."
9	SECT	ION 3. Section 453-8.4, Hawaii Revised Statutes, is
10	amended b	y amending subsection (a) to read as follows:
11	"(a)	The board may summarily suspend any license issued
12	under thi	s chapter [upon]:
13	(1)	Upon a specific determination that the failure to take
14		such an action may result in an immediate and
15		unreasonable threat to personal safety or of fraud
16		that jeopardizes or endangers the health or safety of
17		patients as determined by the professional standards
18		of care upon consumers, and that, for the protection
19		of the public from the possible consequences of such
20		practices, the license should be immediately suspended
21		or restricted[-]; or

1	(2)	Within forty-eight hours upon receipt of evidence of
2		revocation, suspension, or other disciplinary action
3		against a licensee by another state or federal agency
4		and a determination that, for the protection of the
5		public, the license should be immediately suspended or
6		restricted."

Description:

Authorizes the Hawaii Medical Board to impose the same disciplinary action, including prohibiting the practice of medicine, against a licensee as was taken by another state or federal agency. Authorizes the Board to summarily suspend a licensee's license within forty-eight hours upon receipt of evidence of disciplinary action by another state or federal agency.
