- 15 been studied under this part shall be confidential.
- 16 (c) If the [+]birth defects program[+] or researchers
- 17 intend to collect additional information directly from a patient
- 18 or patient's relative for research studies approved by an

2	approval for the request from the patient's primary care
3	provider. If the patient's current physician is not known, the
