SECTION 1. Section 353-16.35, Hawaii Revised Statutes, is

[sixty] thirty days following public notification of either an 1 environmental assessment or an environmental impact statement. 2 (b) Any development or expansion proposal may address the 3 4 construction of the facility together with, or separate from, 5 the operation of the facility and shall consider and include: 6 The percentage of low, medium, and high security (1) inmates and the number of prison or jail beds needed to 7 8 incarcerate each of the foregoing classes of inmates; 9 The facility's impact on existing infrastructure, and (2) 10 an assessment of improvements and additions that will be 11 necessary; 12 The facility's impact on available modes of (3) transportation, including airports, roads, and highways; and 13 14 (4) A useful life costs analysis. 15 (c) For the purposes of this section, "useful life costs" 16 means an economic evaluation that compares alternate building 17 and operating methods and provides information on the design, 18 construction methods, and materials to be use with respect to efficiency in building maintenance and facilities operation." 19 SECTION 2.
