TITLE: A BILL FOR AN ACT RELATING TO CIGARETTE

SHIPPING LABELS.

PURPOSE: To make a technical amendment to section

245-16(b)(3)(B), Hawaii Revised Statutes (HRS), updating the required disclaimer to reference the age of twenty-one rather than the age of eighteen on cigarette shipping

labels.

MEANS: Amend section 245-16(b), HRS.

JUSTIFICATION: The legal age for the purchase of cigarettes

in Hawaii was raised from eighteen to

twenty-one. This measure makes a conforming technical amendment to the cigarette and tobacco tax law which references the legal

age for the purchase of cigarettes.

Impact on the public: This amendment will require the legal notice under section 245-16(b)(3)(B), HRS, to reflect the correct legal age for the purchase of cigarettes, positively impacting the public by requiring

a legally accurate notice.

Impact on the department and other agencies:
This amendment merely makes a technical
conforming amendment to the law and will
have no impact on the department's or other

agencies' operations.
