BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 286-111, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "§286-111 Application for license, provisional license, 4 instruction permit, limited purpose driver's license, limited 5 purpose provisional driver's license, or limited purpose 6 instruction permit; fees. (a) Every application for an 7 instruction permit, provisional license, driver's license, 8 limited purpose driver's license, limited purpose provisional 9 driver's license, or limited purpose instruction permit shall be 10 made upon a form furnished by the examiner of drivers and shall 11 be verified by the applicant before a person authorized to 12 administer oaths. The examiner of drivers and officers serving 13 under the examiner may administer the oaths without charge. 14 Each application for an instruction permit for a category (1), 15 (2), (3), or (4) license shall be accompanied by a fee to be 16 determined by the council of each county, and each application

PURPOSE:

To amend the law relating to fees charged to

driver's license applicants.

MEANS:

Amend section 286-111, Hawaii Revised

Statutes.

JUSTIFICATION:

The computer equipment used in Hawaii's driver licensing program has become quite sophisticated during the State's move to comply with Real ID requirements. example, many of the documents that are presented by applicants can be scanned and quickly authenticated to ensure the applicant's true identity. However, to continue to meet the needs of the licensing program, the computers and software need to be maintained and updated regularly so they are abreast of changes that are made to official documents that are used not only in this country but in many other countries around the world. Although federal funding was used for the acquisition and initial maintenance and update costs, the State must absorb the continuing costs and future updates. Giving the director authority to establish a small application fee can accomplish this.

Impact on the public: The maintenance fee will be less than a dollar, so it will have virtually no financial impact on the public, and the driver's license document will continue to be of high integrity and credibility.

Impact on the department and other agencies:
The department will be able to pay for the software maintenance and upgrades and also

pay some of the other costs associated with keeping the State Real ID compliant. No anticipated impact on other agencies.

The Highway fund will receive about \$110,000 per year primarily to pay for the computer maintenance and software update expenses.
