A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that the Puna district on
3	the island of Hawaii is approximately five hundred square miles
4	and according to a 2010 census, has a population of 45,326.
5	Puna has become the fastest growing district in the State, with
6	a population increase of forty-four per cent since 2000. Over
7	the next fifteen years the population of Puna is expected to be
8	approximately seventy-five thousand. This population growth has
9	significantly impacted the Hawaii county fire department's
10	emergency medical services medic units in Puna and Hilo.
11	The legislature further finds that the residents of Puna
12	are faced with various economic and transportation challenges.
13	Due to the risk of being inundated by lava, portions of Puna are
14	extremely vulnerable and threatened with inaccessibility.
15	Access to health care in Puna is also difficult because many
16	Puna residents are up to thirty miles away from the nearest
17	primary care provider.

- 1 The legislature additionally finds that the Hawaii county
- 2 fire department's emergency medical services has become the
- 3 health care access point for many Puna residents. From 2015 to
- 4 2016, the Puna district accounted for thirty per cent of
- 5 emergency medical service calls. Since 2007, there has been a
- 6 fifty per cent increase in responses from Hilo medic units into
- 7 the Puna district, leaving Hilo without adequate emergency
- 8 medical services. Based in the Keaau and Pahoa fire stations,
- 9 two emergency medical services units handle ninety-one per cent
- 10 of the emergency medical services calls from Puna residents and
- 11 the paramedics face progressive burnout due to long shifts.
- 12 The purpose of this Act is to appropriate funds to
- 13 establish and staff an advanced life support medic unit in Puna
- 14 on the island of Hawaii.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so much
- 17 thereof as may be necessary for fiscal year 2016-2017 to
- 18 establish and staff an advanced life support medic unit in Puna
- 19 on the island of Hawaii.
- The sum appropriated shall be expended by the department of
- 21 health for the purposes of this Act.

PART II

2	SECTION 3. The legislature finds that response times for
3	emergency medical services significantly impact the overall time
4	it takes to transport patients to the emergency room to receive
5	treatment. The National Fire Protection Association, which
6	creates standards for fire services, and has determined that
7	emergency medical services medic unit crews must respond to
8	scenes of emergency within eight minutes. According to the
9	association's publication, NFPA 1710: Standard for the
10	Organization and Deployment of Fire Suppression Operations,
11	Emergency Medical Operations, and Special Operations, "this
12	requirement is based on experience, expert consensus and
13	science. Many studies note the role of time and the delivery of
14	early defibrillation in patient survival due to heart attacks
15	and cardiac arrest which are the most time-critical, resource-
16	intensive medical emergency events to which fire departments
17	respond." Trauma cases are also very time-sensitive, and the
18	ability of emergency medical services crews to rapidly transport
19	patients to medical facilities for treatment often makes the
20	difference between life and death.

1 The legislature further finds that on the island of Hawaii, 2 North Kona's new Makalei fire station fills a firefighting gap 3 on highway 190 between the Kailua fire station and the Waikoloa 4 fire station. The Makalei station has a fire engine, is home to 5 a hazardous materials response unit, and serves a community of 6 approximately forty-five thousand residents in one of the 7 fastest-growing districts in the State. However, current 8 emergency medical services responses to North Kona come from the 9 medic seven unit based at the Kailua fire station, the medic 10 twelve unit based at the Keauhou fire station, and the medic 11 sixteen unit based at the Waikoloa fire station. 12 facilities are located eight, fifteen, and twenty miles from 13 North Kona, respectively. Medics seven and twelve account for 14 seventeen per cent of the emergency medical services calls on 15 the island, and in the best circumstances will respond to North Kona in eight to fifteen minutes. If neither of these units are 16 available, North Kona must rely upon medic sixteen, which **17** 18 usually takes twenty-five to thirty minutes to respond. 19 Further, the approximate transport time from North Kona to Kona

community hospital is twenty to thirty minutes.

1 The legislature further finds that given the current 2 availability of emergency medical services in North Kona, 3 patients who need those services and time-sensitive definitive 4 treatment are at risk of losing their health or their lives. 5 The purpose of this Act is to provide funding for the 6 operation of emergency medical services for North Kona. 7 SECTION 4. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ 9 thereof as may be necessary for fiscal year 2016-2017 for the **10** operation of emergency medical services for North Kona. 11 The sum appropriated shall be expended by the county of **12** Hawaii for the purposes of this Act. 13 PART III

SECTION 5. This Act shall take effect on July 1, 2070.
