

### A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. (a) There is established in each public high
2	school a mock credit union special fund that shall be exempt
3	from chapter 412, Hawaii Revised Statutes, and shall be
4	administered by the principal of each school. The purpose of
5	the special fund in each school shall be to provide short-term
6	loans to students of that school to finance, produce, and sell
7	products for entrepreneurial projects that are sponsored by tha
8	school; provided that:
9	(1) No single loan transaction shall exceed \$100;
10	(2) Each loan shall be co-signed by the student's parent
11	or legal guardian; and
12	(3) The student presents, with the loan application, a
13	business plan that shall include:
14	(A) A prototype of the product to be sold;
15	(B) The number of items to be produced; and
16	(C) A repayment schedule.
17	(b) The revenues of the special fund shall consist of:

1 (1) Loan repayments; 2 (2) Fees and fines; 3 (3) Gifts, donations, and grants from any source; and 4 Legislative appropriations. (4) The department of education shall adopt rules for the 5 uniform implementation of this Act among the public high 6 schools, including forms for loan applications and business 7 8 plans. 9 The department of education shall submit interim reports and a final report to the legislature not later 10 than twenty days prior to the convening of the 2017, 2018, 2019, 11 2020, and 2021 regular sessions on its findings and 12 13 recommendations on the mock credit union and loan program 14 established pursuant to this Act. SECTION 3. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$ or so much 16 thereof as may be necessary for fiscal year 2016-2017 for 17 deposit into the mock credit union special funds established 18 19 under this Act.
