A BILL FOR AN ACT

RELATING TO LAW ENFORCEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii is the only
- 2 state in the country without a statewide board for law
- 3 enforcement employment standards or training. Given the immense
- 4 power and authority that the State and counties grant to police,
- 5 sheriffs, and other law enforcement officers who carry firearms,
- 6 it is important to establish recommended statewide standards for
- 7 these officers. These standards would benefit county and state
- 8 departments or agencies, as well as the general public.
- 9 Accordingly, the purpose of this Act is to establish an
- 10 advisory law enforcement employment standards and training board
- 11 responsible for recommending statewide standards for employment
- 12 and training to be implemented by state and county government
- 13 agencies for their law enforcement officers who carry firearms
- 14 and wear badges.
- 15 SECTION 2. The Hawaii Revised Statutes is amended by
- 16 adding a new chapter to be appropriately designated and to read
- 17 as follows:

3	§ -1 Definitions. As used in this chapter, unless the		
4	context clearly indicates otherwise, the following terms shall		
5	mean as follows:		
6	"Advisory board" means the advisory law enforcement		
7	employment standards and training board.		
8	"Law enforcement officer" means:		
9	(1) A police officer employed by a county police		
10	department who wears a badge and carries a firearm;		
11	(2) A public safety officer employed by the department of		
12	public safety who wears a badge and carries a firearm;		
13	(3) An employee of the department of transportation or the		
14	department of land and natural resources who wears a		
15	badge and carries a firearm; or		
16	(4) An employee of a government agency's vendor or		
17	contractor who is permitted to wear a badge and carry		
18	a firearm.		
19	§ -2 Creation of advisory law enforcement employment		
20	standards and training board; composition. (a) There is

4	(1)	The state sheriff or the sheriff's designee;	
5	(2)	Two members of the public not currently employed by a	
6		government agency, one of whom shall have a background	
7		in criminal justice, shall be appointed by the	
8		governor, in accordance with section 26-34;	
9	(3)	Two members of the public not currently employed by a	
10		government agency, one of whom shall have a legal	
11		background, shall be appointed by the governor from a	
12		list of two nominees submitted by the president of the	
13		senate; and	
14	(4)	Two members of the public not currently employed by a	
15		government agency, one of whom shall have a background	
16		in human resources management, shall be appointed by

- 1 (b) The terms of the members shall end on June 30, 2021.
- 2 (c) The advisory board shall select a chairperson from
- 3 among its members; provided that the chairperson shall not be a
- 4 current law enforcement officer.
- 5 (d) When a vacancy occurs on the advisory board, the
- 6 successor shall be appointed in the same manner as the
- 7 predecessor member who vacated a position on the advisory board.
- 8 S -3 Duties. (a) Between January 1, 2017, and
- 9 September 30, 2018, the advisory board shall hold meetings at
- 10 least once every quarter; provided that the meetings shall be
- 11 open to the public in accordance with chapter 92.
- 12 (b) By January 7, 2019, the advisory board shall propose
- 13 recommendations for statewide employment standards and training
- 14 for law enforcement officers who wear badges and carry firearms.
- 15 The proposed standards and training recommendations may include
- 16 but not be limited to age requirements, education requirements,
- 17 criminal background checks, hearing tests, eye examinations,
- 18 psychological tests, physical ability tests, and other
- 19 requirements necessary to become a law enforcement officer. The
- 20 advisory board may work or collaborate with existing law
- 21 enforcement agencies to develop the proposed employment

- 1 standards and training recommendations. The advisory board
- 2 shall make the proposed standards and training recommendations
- 3 available for public review and comment for a period of not less
- 4 than ninety days. The advisory board shall hold at least two
- 5 public hearings on the proposed standards and training
- 6 recommendations by March 31, 2019.
- 7 (c) After the period of public review and comment, the
- 8 advisory board shall adopt final statewide employment standards
- 9 and training recommendations and transmit them to relevant
- 10 government agencies by July 31, 2019.
- 11 (d) Beginning July 31, 2019, the advisory board shall meet
- 12 at least twice a year to review the statewide employment
- 13 standards and training recommendations and extent of
- 14 implementation by the relevant government agencies.
- 15 § -4 Employment standards and training recommendations;
- 16 voluntary implementation. Each government agency may
- 17 voluntarily implement the employment standards and training
- 18 recommendations for its law enforcement officers who wear badges
- 19 and carry firearms.
- 20 § -5 No cause of action for not implementing
- 21 recommendation. No person shall have a cause of action against

- 1 the State or any county, government agency, or law enforcement
- 2 or other officer for the decision by a government agency to not
- 3 implement any employment standard or training recommendation of
- 4 the advisory board.
- 5 S -6 No county mandate. Nothing in this chapter shall
- 6 be construed to require a political subdivision of this State to
- 7 undertake a new program or increase the level of service of an
- 8 existing program that would require cost sharing by the State
- 9 under article VIII, section 5, of the Constitution of the State
- 10 of Hawaii.
- If any provision of this chapter is deemed to be such a
- 12 mandate upon a political subdivision, the provision shall be
- 13 void and no longer in effect.
- 14 § -7 Termination of advisory board. On June 30, 2021,
- 15 the advisory board shall terminate."
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2016-2017 for
- 19 the operation of the advisory law enforcement employment
- 20 standards and training board.

- 1 The sum appropriated shall be expended by the department of
- 2 the attorney general for the purposes of this Act.
- 3 SECTION 4. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 5. This Act shall take effect on January 7, 2059,
- 7 and shall be repealed on June 30, 2021.
