A BILL FOR AN ACT

RELATING TO NON-GENERAL FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to address the
- 2 distribution of cigarette tax revenues.
- 3 During the regular session of 2015, Act 238 was enacted to
- 4 set maximum amounts on the distribution of cigarette tax
- 5 revenues to various non-general funds, with the remainder to be
- 6 deposited into the general fund. The legislature took this
- 7 action to increase legislative oversight of agencies and
- 8 programs supported by cigarette tax revenues, and subject those
- 9 agencies and programs to competition for limited public funds by
- 10 restricting their automatic share of cigarette tax revenues.
- 11 This Act expands the legislature's focus on the
- 12 distribution of cigarette tax revenues. The legislature finds
- 13 that focusing on the cigarette tax is imperative because these
- 14 tax revenues are declining, a laudable result of public health
- 15 efforts. Consequently, evaluation of the future budgetary needs
- 16 and funding of agencies and programs dependent on cigarette tax
- 17 revenues should commence now.

- 9 SECTION 3. Upon the request of the department of budget
 10 and finance for assistance and information, the department of
 11 health, department of taxation, and any other relevant executive
 12 department shall cooperate with the department of budget and
 13 finance.
- 14 SECTION 4. The department of budget and finance shall
 15 submit the findings and recommendations of the study to the
 16 legislature and governor by November 1, 2016.
- 17 SECTION 5. This Act shall take effect on July 1, 2016.
