A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the wage standards 2 division of the department of labor and industrial relations had 3 a backlog of approximately four hundred twenty complaints as of October 9, 2015. Two hundred eleven of those complaints are 4 5 prevailing wage claims against fifty-eight employers on one hundred fifty projects, which amounts to one hundred fifty 6 7 pending prevailing wage investigations conducted pursuant to chapter 104, Hawaii Revised Statutes. The wage standards 8 9 division receives an average of fifty-six prevailing wage 10 complaints per year. Over the last ten years, however, the wage 11 standards division finished, on average, thirty-five prevailing wage complaints each year. Unless the division receives more 12 staff and resources, the division will not be able to reduce its 13 backlog of wage complaints. 14 15 The legislature further finds that the division requires

- 13 enforcement specialist IV positions and two permanent, full-time
- 14 equivalent labor law enforcement specialist III positions,
- 15 subject to chapters 76 and 89, Hawaii Revised Statutes, and for
- 16 other expenses related to these positions.
- 17 The sum appropriated shall be expended by the department of
- 18 labor and industrial relations for the purposes of this Act.
- 19 SECTION 3. This Act shall take effect on July 1, 2076.
