A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR A SHOOTING FACILITY IN WEST HAWAII ON THE ISLAND OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii island
- 2 residents acquire six thousand firearms each year, adding to the
- 3 estimated quarter million guns currently in their possession.
- 4 Ninety per cent of those firearms are rifles and pistols, for
- 5 which no safe, legal, and publicly accessible shooting facility
- 6 exists. At risk of arrest and gun confiscation, Hawaii island
- 7 firearms owners are left to discharge their legally owned
- 8 firearms at numerous makeshift shooting ranges where personal
- 9 injury and property damage have occurred, and remain major
- 10 concerns.
- 11 The legislature also finds that the development of a legal
- 12 public shooting facility on Hawaii island has been discussed for
- 13 several decades. In 2004, Hawaii island residents formed a
- 14 working group to determine user requirements for an island
- 15 shooting facility, and to initiate effort towards its
- 16 development. Working group participants later incorporated as a

- 1 nonprofit organization to better assist development of a public
- 2 shooting facility. In 2005, a barren lava field in the
- 3 Puuanahulu state game management area on the northeast boundary
- 4 of the Puuanahulu landfill, and south of the Blue Hawaiian
- 5 heliport, was selected as site for the proposed public shooting
- 6 facility. Between 2012 and 2015, three sound tests and two
- 7 public hearings were conducted to gauge community support. The
- 8 development of a public shooting facility elicited unanimous
- 9 public support at the public hearings.
- 10 The purpose of this Act is to continue development of a
- 11 Hawaii island public shooting facility by funding public
- 12 outreach, planning, and an environmental impact statement.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$800,000 or so much
- 15 thereof as may be necessary for fiscal year 2016-2017 for public
- 16 outreach, planning, and an environmental impact statement for a
- 17 public shooting facility in west Hawaii on the island of Hawaii.
- 18 The sum appropriated shall be expended by the department of
- 19 accounting and general services for the purposes of this Act.
