A BILL FOR AN ACT

RELATING TO URBAN SCHOOL IMPACT DISTRICTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 302A-1608, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§302A-1608 Accounting and expenditure requirements. (a)
- 4 Each designated school impact district shall be a separate
- 5 benefit district. Fees collected within each school impact
- 6 district shall be spent only within the same school impact
- 7 district for the purposes collected.
- 8 (b) Land dedicated by the developer shall be used only as
- 9 a site for the construction of one or more new schools or for
- 10 the expansion of existing school facilities. If the land is
- 11 never used for the school facility, it shall be returned to the
- 12 developer, or the developer's successor in interest. Once used,
- 13 the land may be sold, with the proceeds used to acquire land for
- 14 school facilities in the same school impact district.
- (c) If the land is not used for a school facility within
- 16 twenty years of its dedication, it shall be returned to the
- 17 developer, or the developer's successor in interest.

- 1 (d) Once used for school facilities, all or part of the
- 2 land may be later sold. Proceeds from the sale shall be used to
- 3 acquire land for school facilities in the same school impact
- 4 district.
- 5 (e) Fee in lieu funds may be used for school site land
- 6 acquisition and related expenses, including surveying,
- 7 appraisals, and legal fees. [Fee] With the exception of urban
- 8 Honolulu, fee in lieu funds shall not be used for the
- 9 maintenance or operation of existing schools in the district[7];
- 10 construction costs, including architectural, permitting, or
- 11 financing costs $[\tau]$; or for administrative expenses.
- 12 (f) Notwithstanding subsection (e), in urban Honolulu, fee
- 13 in lieu funds may be used to purchase completed construction,
- 14 construct new school facilities, improve or renovate existing
- 15 structures for school use, or lease land or facilities for

- 17 [(f)] (g) Construction cost component impact fees shall be
- 18 used only for the costs of new school facilities that [expands]
- 19 expand the student capacity of existing schools or adds student
- 20 capacity in new schools. Construction cost component impact
- 21 fees may not be used to replace an existing school located

- 3 [(g)] (h) Eligible construction costs include planning,

- 1 encumbered within twenty years of the date of collection. Fees
- 2 shall be considered spent or encumbered on a first-in, first-out
- 3 basis. An expenditure plan for all collected impact fees shall
- 4 be incorporated into the annual budget process of the department
- 5 and subject to legislative approval of the budget.
- 6 (1) As used in this section, "urban Honolulu" means the
- 7 Kalihi to Ala Moana school impact district."

- 9 and stricken. New statutory material is underscored.
- 10 SECTION 3. This Act shall take effect upon its approval.
