A BILL FOR AN ACT

RELATING TO AUTHORIZED EMERGENCY VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature has received numerous sound
- 2 complaints related to the unnecessary use of sirens by emergency
- 3 vehicles, often late at night, when it is clear that no one is
- 4 on the streets. People who live next to a fire station may be
- 5 awakened several times each night by the sirens of a fire truck
- 6 leaving the station.
- 7 The purpose of this Act is to authorize emergency
- 8 responders to exercise discretion in their use of sirens while
- 9 maintaining compliance with the best practices of their
- 10 profession. Police already exercise discretion in their use of
- 11 sirens, and this measure provides that same discretion to other
- 12 drivers of authorized emergency vehicles.
- 13 SECTION 2. Section 291C-26, Hawaii Revised Statutes, is
- 14 amended by amending subsections (c) and (d) to read as follows:
- "(c) The exemptions granted in subsection (b) to an
- 16 authorized emergency vehicle shall apply only when the vehicle
- 17 is making use of authorized audible and visual signals, except
