H.B. NO. 2584

A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii is located approximately 2,506 miles from the continental United States. 2 3 About eighty-five to ninety per cent of Hawaii's food is imported, which makes Hawaii particularly vulnerable to natural 4 disasters and global events that disrupt shipping and other 5 6 modes of transporting food. Furthermore, the economic impact of food import replacement is significant. Food expenditures of 7 local consumers from 2004 to 2005 amounted to \$3,700,000,000. 8 Assuming that eighty-five per cent of the food consumed in the 9 State is imported, this translates to \$3,145,000,000 of food 10 expenditures leaving the State each year. Growing food within 11 12 the State enables the expenditures on food to remain in the 13 local economy.

14 The development of a whole farm system approach to 15 agriculture in Hawaii that pays close attention to soil health, 16 specifically increasing mineral availability and improving soil 17 structure, water-holding capacity, crop health, and food



1 nutrition levels, will lower water usage through deployment of 2 green manure, compost, and cover crops; reduce crop loss from 3 pest damage; and decrease weed pressure. This whole farm system 4 approach to agriculture can improve food security and benefit 5 the local economy through reducing production costs by promoting 6 locally sourced inputs and the manufacturing thereof. Teaching 7 a new generation of farmers to use this whole farm system approach will create an alternative method of farming that 8 9 appeals to many young farmers across the State. Currently, 10 there is a shortage of qualified teachers for these farm 11 methods. On-farm mentoring aims to fulfill this need by 12 bringing the students to the farm and providing qualified farm 13 mentors with funding.

14 The purpose of this Act is to improve food security and 15 self-sufficiency in the State by encouraging the development and 16 implementation of a whole farm system approach to agriculture in 17 Hawaii.

18 SECTION 2. (a) There is established in the department of 19 agriculture an on-farm mentoring program that shall provide 20 existing on-farm mentoring programs with funding support to 21 teach farmers about methods to improve soil health by using

1 whole farm systems that practice sustainable agriculture as 2 defined by the Food, Agriculture, Conservation, and Trade Act of 3 1990, Public Law 101-624, title XVI, subtitle A, section 1603, 4 that recycle locally available organic, diverse plant and animal 5 agricultural nutrients, enhanced by fermentation and other 6 ecological processes such as Korean natural farming as defined 7 by the University of Hawaii college of tropical agriculture and 8 human resources.

9 (b) The chairperson of the board of agriculture shall 10 appoint one or more on-farm mentors for each island with a 11 population greater than five thousand; provided that the 12 chairperson of the board of agriculture may appoint an on-farm 13 mentor for an island with a population of five thousand or fewer 14 upon request.

15 (c) The department of agriculture shall establish 16 curriculum for the on-farm mentoring program in collaboration 17 with the education committee of the Hawaii Farmers Union United, 18 which:

(d) The department of agriculture, as part of the on-farm
mentoring program, shall provide grants to support existing on farm mentoring programs and a pilot on-farm mentoring program in
the county of Maui.

5 SECTION 3. There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$500,000 or so much 7 thereof as may be necessary for fiscal year 2016-2017 as a grant 8 pursuant to chapter 42F, Hawaii Revised Statutes, to existing 9 on-farm mentoring programs and a pilot on-farm mentoring program 10 in the county of Maui to provide mentoring on a whole farm 11 system approach to agriculture.

12 The sum appropriated shall be expended by the department of 13 agriculture for the purposes of this Act.

14 SECTION 4. This Act shall take effect on July 1, 2016.
