A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that, according to the SECTION 1. 2 city and county of Honolulu's 2015 report entitled "Homeless 3 Point-in Time Count," the number of homeless people jumped by 4 about four per cent compared to the previous year. Despite increased effort and resources, such as officials offering 5 6 homeless services and the proposed use of shipping containers as 7 temporary housing, homelessness in Oahu has not improved. 8 The legislature further finds that there are programs being 9 introduced throughout the United States that help homeless 10 individuals find work and afford shelter. A pilot program was 11 launched by the mayor of Albuquerque, New Mexico, that assists 12 individuals in leaving the streets and connecting them with 13 The pilot program is proving to be a success and is 14 getting national attention. A similar program that was 15 introduced in Tucson, Arizona, assists homeless individuals in 16 achieving temporary jobs. In partnership with the Primavera 17 Foundation, the Primavera Works program is an employment program

- 1 that serves as a nonprofit, staffing service that offers job
- 2 training and provides temporary jobs, with the potential of
- 3 becoming permanent jobs. The legislature finds that launching a
- 4 pilot program on Oahu that is similar to those found in
- 5 Albuquerque, New Mexico, and Tucson, Arizona, would give
- 6 homeless individuals day jobs. Citations and jail time are
- 7 disruptive events that only increase the likelihood of people
- 8 relying on panhandling for income. Providing more proactive
- 9 services, such as jobs and counseling to build up a person's
- 10 self-esteem, would help reduce poverty and homelessness on Oahu.
- 11 The purpose of this Act is to assist homeless individuals
- 12 in finding jobs by requiring the city and county of Honolulu to
- 13 establish a pilot program connecting homeless individuals who
- 14 are willing to work with job opportunities.
- 15 SECTION 2. (a) There is established a three-year work for
- 16 a day pilot program to be administered by the city and county of
- 17 Honolulu. The purpose of the work for a day pilot program is to
- 18 assist homeless individuals in finding work opportunities.
