### A BILL FOR AN ACT

RELATING TO HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that persons with severe
- 2 persistent mental illness often require specialized residential
- 3 services. However, the high cost of housing creates a shortage
- 4 of available homes for these individuals, and often, the
- 5 severely mentally ill become homeless. The legislature further
- 6 finds that the development of project-based housing as a bridge
- 7 to permanent housing is difficult to develop due to high costs.
- 8 Accordingly, the purpose of this Act is to authorize the
- 9 use of the rental housing revolving fund and dwelling unit
- 10 revolving fund moneys for rent subsidies, and to provide for
- 11 permanent housing, bridge housing, and specialized residential
- 12 services for persons with serious mental illnesses.
- 13 SECTION 2. Section 201H-191, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "[+] \$201H-191[+] Dwelling unit revolving fund. There is
- 16 created a dwelling unit revolving fund. The funds appropriated
- 17 for the purpose of the dwelling unit revolving fund and all



- 1 moneys received or collected by the corporation for the purpose
- 2 of the revolving fund shall be deposited in the revolving fund.
- 3 The proceeds in the revolving fund shall be used to reimburse
- 4 the general fund to pay the interest on general obligation bonds
- 5 issued for the purposes of the revolving fund, for the necessary
- 6 expenses in administering housing development programs, and for
- 7 carrying out the purposes of housing development programs,
- 8 including but not limited to the expansion of community
- 9 facilities constructed in conjunction with housing projects,
- 10 permanent primary or secondary financing, and supplementing
- 11 building costs, federal guarantees required for operational
- 12 losses, and all things required by any federal agency in the
- 13 construction and receipt of federal funds or low-income housing
- 14 tax credits for housing projects. The proceeds in the revolving
- 15 fund shall also be used to provide specialized residential
- 16 services and rent subsidies for residential housing, including
- 17 multi-family units, apartments, residential houses, or other
- 18 types of housing for residents who qualify for social security
- 19 disability benefits and are diagnosed with a life-long, serious
- 20 mental illness."

12		Development and United States Department of
13		Agriculture Rural Development wherein:
14		(A) At least fifty per cent of the available units
15		are for persons and families with incomes at or
16		below eighty per cent of the median family income
17		of which at least five per cent of the available
18		units are for persons and families with incomes
19		at or below thirty per cent of the median family
20		income; and

1		(B) The remaining units are for persons and families
2		with incomes at or below one hundred per cent of
3		the median family income;
4		provided that the corporation may establish rules to
5		ensure full occupancy of fund projects; [and]
6	(2)	Mixed-income rental projects or units in a
7		mixed-income rental project wherein all of the
8		available units are for persons and families with
9		incomes at or below one hundred forty per cent of the
10		median family income[-]; and
11	(3)	Residential housing, including multi-family units,
12		apartments, residential houses, or other types of
13		housing, and specialized residential services, for
14		residents who qualify for social security disability
15		benefits and are diagnosed with a life-long, serious
16		mental illness."
