A BILL FOR AN ACT

RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS FOR WAILUKU RESERVOIR #6.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds and declares that the
- 2 issuance of special purpose revenue bonds under this Act is in
- 3 the public interest and for the public health, safety, and
- 4 general welfare.
- 5 SECTION 2. Pursuant to Act , Session Laws of Hawaii
- 6 2016, the department of budget and finance, with the approval of
- 7 the governor, is authorized to issue special purpose revenue
- 8 bonds in a total amount not to exceed \$800,000 in one or more
- 9 series, for the purpose of providing financing to Spencer Homes,
- 10 Inc., a Hawaii corporation, to fill in and decommission Wailuku
- 11 water reservoir 6. The legislature hereby finds and determines
- 12 that Wailuku water reservoir 6 constitutes a project as defined
- 13 in Act , Session Laws of Hawaii 2016, and the financing
- 14 thereof is assistance to dam and reservoir owners.
- 15 SECTION 3. The special purpose revenue bonds and the
- 16 refunding special purpose revenue bonds issued under this Act

- 1 shall be issued pursuant to Act , Session Laws of Hawaii
- 2 2016, relating to the power to issue special purpose revenue
- 3 bonds to assist dam and reservoir owners.
- 4 SECTION 4. The department of budget and finance is
- 5 authorized, from time to time, including times subsequent to
- 6 June 30, 2021, to issue special purpose revenue bonds in
- 7 whatever principal amounts the department shall determine to be
- 8 necessary to refund the special purpose revenue bonds authorized
- 9 in section 2 of this Act and to refund special purpose revenue
- 10 bonds authorized by this section, regardless of whether the
- 11 outstanding special purpose revenue bonds or refunding special
- 12 purpose revenue bonds have matured or are the subject of
- 13 redemption or whether the refunding special purpose revenue
- 14 bonds shall be bonds for the multi-project programs described in
- 15 section 2. In making this determination, the department shall
- 16 comply with federal law relating to the exemption from federal
- 17 income taxation of the interest on bonds of the nature
- 18 authorized by this section.
- 19 SECTION 5. The authorization to issue special purpose
- 20 revenue bonds under this Act shall lapse on June 30, 2021.

L	SECTION 6. The revisor of statutes shall insert the act
2	number for H.B. No. 2058, as enacted by the legislature in the
3	2016 regular session, as the act referenced in sections 2 and 3.
