BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds and declares that the
- 2 issuance of special purpose revenue bonds under this Act is in
- 3 the public interest and for the public health, safety, and
- 4 general welfare.
- 5 SECTION 2. Pursuant to Act 147, Session Laws of Hawaii
- 6 2012, the department of budget and finance, with the approval of
- 7 the governor, is authorized to issue special purpose revenue
- 8 bonds in a total amount not to exceed \$800,000 in one or more
- 9 series, for the purpose of providing financing to Spencer Homes,
- 10 Inc., a Hawaii corporation, to properly breach, modify, or
- 11 provide improvements to Wailuku Reservoir No. 6, subsequent to
- 12 all applicable permit requirements. The legislature hereby
- 13 finds and determines that Wailuku reservoir number 6 constitutes
- 14 a project as defined in Act 147, Session Laws of Hawaii 2012,
- 15 and the financing thereof is assistance to dam and reservoir
- 16 owners.
