### A BILL FOR AN ACT

RELATING TO THE STATE CAPITOL.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in our post-2 September 11th world, terrorism, violence, and threats of 3 violence in public forums have become increasingly common and 4 our state government must do more to ensure that citizen 5 engagement does not come at the expense of public safety. At 6 the federal level, the United States Department of Homeland 7 Security's Interagency Security Committee, whose mission is to 8 develop security standards and best practices for nonmilitary 9 federal facilities, has issued guidance detailing "best 10 practices" and recommendations for the protection of federal 11 facilities, employees, contractors, and visitors, and these 12 recommendations include using security countermeasures such as 13 metal detectors and x-ray machines at pedestrian and public 14 entrances of federal buildings. According to the National 15 Conference of State Legislatures, twenty-eight states currently 16 utilize walk-through metal detectors at the public entrances of 17 their capitol buildings. 1 members of the public to come to court and observe firsthand the 2 administration of justice - but also requires all visitors to first pass through metal detectors and have their personal 3 4 belongings undergo x-ray baggage screening. In contrast, the 5 Hawaii state capitol building is known as one of the most 6 publicly accessible capitol buildings in the nation, but is also one of the most vulnerable - precisely because there are no 7 8 provisions for mandatory security screening of visitors.

9 The legislature also finds that the value of open access to 10 "the people's house" must be balanced with the need to ensure 11 the physical safety and well-being of the visiting public, 12 capitol staff, legislators, and other building occupants. The 13 legislature further finds that it is within the purview of the state capitol management committee, established pursuant to Act 14 15 97 of the regular session of 2014 and now codified in section 16 6E-34.5, to develop and implement a master security plan that 17 will increase safety and security in the Hawaii state capitol 18 building through the mandatory use of metal detectors, x-ray 19 scans of baggage, and other prudent measures. The development and implementation of such a security plan is consistent with 20 21 the committee's authority to oversee and manage the state

1 master security plan shall be as follows: 2 (1) July 1, 2016 through December 31, 2016 for completion 3 of Phase I; 4 (2) January 1, 2017 through December 31, 2017 for 5 completion of Phase II; 6 (3) January 1, 2018 through December 31, 2018 for 7 completion of Phase III; and 8 (4) January 1, 2019 through December 31, 2020 for 9 completion of Phase IV. 10 SECTION 3. The state capitol management committee shall 11 submit to the legislature a written report of its progress on 12 the master security plan no later than twenty days prior to the 13 convening of the 2017, 2018, 2019, 2020, and 2021 legislative 14 sessions. 15 This Act shall take effect upon its approval.
