A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE COUNTY OF KAUAI.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The director of finance is authorized to issue
2	general obligation bonds in the sum of \$12,250,000 or so much
3	thereof as may be necessary and the same sum or so much thereof
4	as may be necessary is appropriated for fiscal year 2016-2017
5	for the purpose of capital improvement projects for the
6	department of water, county of Kauai, as follows:
7	A. Lihue/Kapaa water system, construct Kapaa homesteads 313'
8	tanks, 1.0 MG, Kauai
9	Construction of two 0.5 million
10	gallon storage tanks with a

- 1 SECTION 2. The appropriation made for the capital
- 2 improvement projects authorized by this Act shall not lapse at
- 3 the end of the fiscal biennium for which the appropriation is
- 4 made; provided that all moneys from the appropriation
- 5 unencumbered as of June 30, 2018, shall lapse as of that date.
- 6 SECTION 3. The sums appropriated for the respective
- 7 capital projects set forth in section 1 shall be expended by the
- 8 department of water, county of Kauai for the purposes of this
- 9 Act.
- 10 SECTION 4. This Act shall take effect on July 1, 2050.
